On June 3, 2014, the Board of Supervisors approved Resolution 2014-56, which increased the membership of the Pima County Fair Commission (Commission) from five to seven.

As discussed in the attached letter from Chair Judy Patrick, the Commission conducted an appropriate recruitment/selection process. The selection process was extensive and thorough, and the Commission recommends the appointment of Mr. Garrett Ham.


