Agenda Item Report

Introduction / Background: The base salary for a Pima County Justice of the Peace is calculated as a

percentage of the Arizona Superior Court Judge's base salary, based on the specific

court's Judicial Productivity Credits.

In accordance with Arizona Revised Statute 22-125, the Arizona Supreme Court annual performs the salary calculation for each Justice Court for the previous twelve-month period ending on June 30 to determine the total judicial productivity credits of each court. The Arizona Supreme Court reports the total Judicial Productivity Credits for each Justice Court to the applicable Board of Supervisors within one hundred twenty days after the end of each twelve-month period.

Adjustments to the salary of a Pima County Justice of the Peace made in accordance with this statute are effective on January 1 of the following year.

Discussion: The Arizona Supreme Court's Administrative Office of the Courts has conducted the

annual review required under A.R.S. 22-125 and notified the Pima County Board of Supervisors of the Judicial Productivity Credits received by each Pima County Justice of the Peace. A.R.S. 22-125 specifies what percentage of the Superior Court Judge's base salary each Justice of the Peace shall receive. Since the salary of an Arizona Superior Court Judge is to increase to \$200,000 on January 1, 2026, the salary of each Pima County Justice of the Peace shall increase in accordance

with each Justice's Productivity Credits.

Conclusion: In accordance with A.R.S. 22-125, the Supreme Court has provided the Judicial

Productivity Credits for each Pima County Justice of the Peace, which is used to

calculate the salary of each Justice of the Peace effective January 1, 2026.

Recommendation: It is recommended that the Arizona Supreme Court's Judicial Productivity Credits for

each Pima County Justice of the Peace be reviewed and the identified salary

adjustments be approved.

Fiscal Impact: The estimated total cost of the increase in salary and benefits is \$91.556
