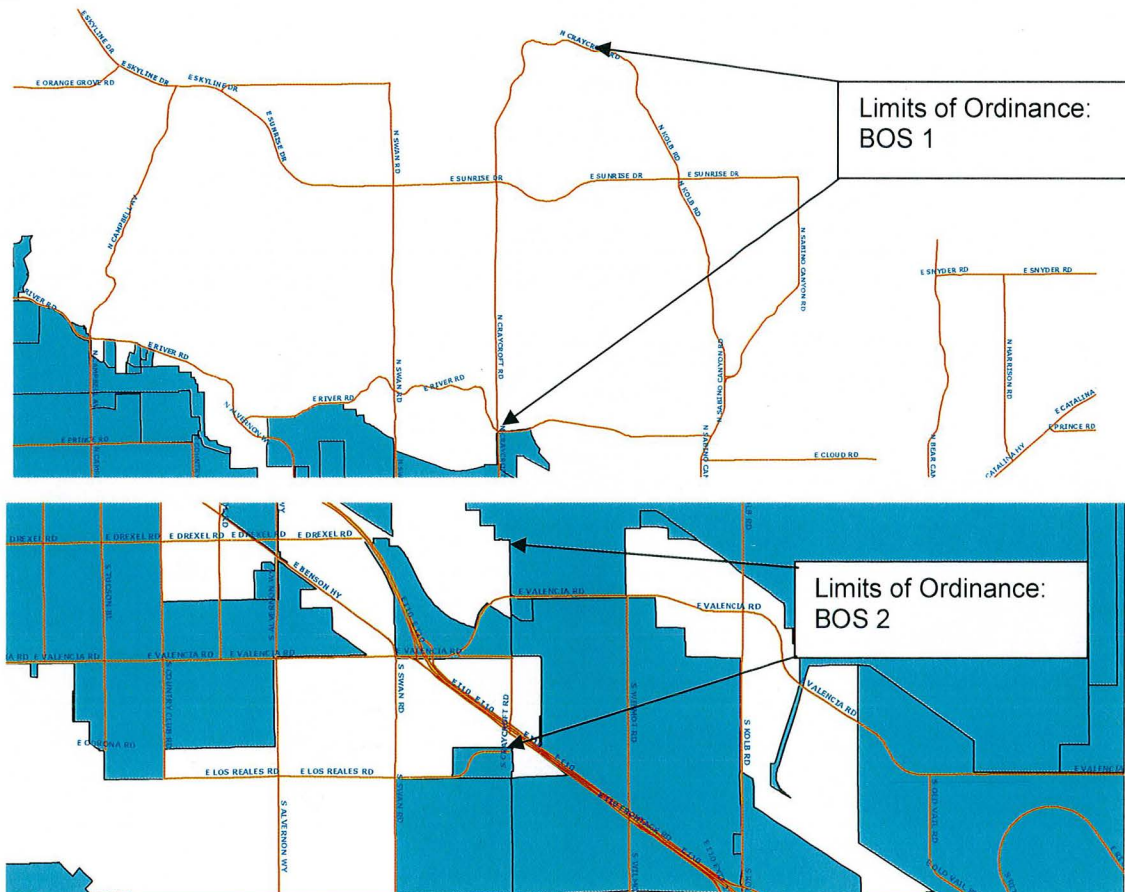

**ORDINANCE NO. 2013-\_\_**

**AN ORDINANCE OF THE PIMA COUNTY BOARD OF  
SUPERVISORS ESTABLISHING PRIMA FACIE  
REASONABLE SPEED LIMITS FOR MOTOR VEHICLES ON  
CRAYCROFT ROAD IN PIMA COUNTY, ARIZONA**

**WHEREAS**, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627, 28-701 and 28-703, as amended, to fix prima facie reasonable speed limits on through highways, and

**WHEREAS**, the Board of Supervisors of Pima County, Arizona, has determined the prima facie reasonable speed limits for motor vehicles on portions of Craycroft Road,

**THEREFORE, IT IS HEREBY ORDAINED** by the Board of Supervisors of Pima County, Arizona, that:

**SECTION 1.** The reasonable and safe prima facie speed limit on Craycroft Road shall be established as follows:

	<u>SPEED LIMIT</u>	<u>FROM</u>	<u>TO</u>
a)	35 mph	180 feet north of Los Reales Road	Littletown Road (City of Tucson limits)
b)	45 mph	Valencia Road	Drexel Road
c)	45 mph	River Road (City of Tucson limits)	Sunrise Drive
d)	40 mph	Sunrise Drive	Ventana Heights Place

**SECTION 2.** Ordinances 1992-099 Sect 1 (115-118) and 2006-66 are repealed and all other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

**SECTION 3.** This ordinance shall take effect when and to the extent that signs are posted on the highways herein listed giving notice of the prima facie reasonable speed limits.

**SECTION 4.** Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

**SECTION 5.** The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.


