Metrics will be collected through Library data gathering reports. In addition staff will answer questions how they can measure their own learning; and design the direction of their work life and how they can engage effectively in a diverse community. Measure of staff who attend trainings and the number of ideas from trainings that are implemented successfully within the library.
