#### \*Project Title/Description:

FY19 Improving Reentry for Adults with Co-occurring Substance Abuse and Mental Illness, the Pima County Inmate Navigation, Verification, Enrollment, Support and Treatment (INVEST) program.

#### \*Purpose:

A request to the Department of Justice for a twelve-month (12) program period, no cost extension was requested, and approval was granted to the Behavioral Health Department for the INVEST grant program. The initial program period started on 10/1/2019 and was to end on 09/30/2023. The no cost extension request extends the grant program period for an additional 12 months effective 10/1/2023 through 09/30/2024. Initiation of this project was necessarily delayed by the reallocation of staff toward the COVID-19 response and reduced the engagement of the program due to COVID restrictions. The twelve-month no-cost-extension will allow the INVEST grant program to continue in order to fulfill the objectives of the grant award and spend down the grant funding.

#### \*Procurement Method:

This agreement is a non-procurement agreement and not subject to procurement rules.

#### \*Program Goals/Predicted Outcomes:

Funding awarded to the Pima County Behavioral Health Department has provided high- and moderate-risk detainees with dual diagnoses linkage to care and assistance with insurance and service enrollment. Services including industry-recognized vocational certification, recovery support, and evidence-based behavioral therapies, are provided to INVEST program participants during both pre- and post-release from detention. In addition, program participants are receiving extensive case management for up to 60 days after release, to include housing and employment support.

#### \*Public Benefit:

Policies designed to reduce recidivism align with Pima County initiatives to increase public safety and allow law enforcement to focus crime-solving resources, while reducing tax-payer burdens related to housing detainees who would be better served if they received behavioral and medical healthcare in appropriate settings.

#### \*Metrics Available to Measure Performance:

Program performance under this award is measured by the percent reduction in recidivism.

#### \*Retroactive:

Yes, the Department of Justice sent notice of approval for the no cost extension on 07/29/2021. There is no evidence that the no cost extension was presented to the Board of Supervisors for approval.

Justification

We are writing to request a 12-month Project Period Extension to award 2019-RW-BX-007, "Pima County INVEST" from the current end date of September 30, 2023 to September 30, 2024. The timeline for initiation of the implementation phase was delayed owing to the reallocation of key INVEST program staff to COVID-19 response during the planning phase. If the extension period is granted, we will be able to complete our planned empirical test of the effectiveness of this intervention. Our evaluation plan includes a randomized controlled trial designed to provide sufficient data needed to understand if this intervention is effective. Without the extension, our capacity to make claims about the broader effectiveness of this intervention for use in other justice-involved populations will be limited. The attached revised timeline details our plan to accomplish this goal.
