

Board of Supervisors Selection Process – District 3

1. Applicants for the position need to meet the following statutory requirements:
 - 18 years of age or older at the time of appointment
 - Resident of the state
 - Resident of the district
 - An elector of the county or precinct in which the duties of the office are to be exercised
 - Literate in English
 - Same political party as the person vacating the office (Democrat)
2. Interested parties are required to file the following documents with the Clerk of the Board:
 - Letter of Interest
 - Resume
 - Financial Disclosure Statement
 - Questionnaire
3. The Clerk of the Board will begin accepting the required documents on November 22, 2023, at 9:00 a.m.
4. The submission deadline will be on Friday, December 1, 2023, at 5:00 p.m.
5. The Clerk of the Board will post the selection process information on the Pima County Homepage. Information regarding how to submit public comments will be included.
6. If requested by the Board of Supervisors, a virtual public forum for the candidates will be scheduled and conducted by the League of Women Voters of Greater Tucson.
7. An update will be provided at the Board of Supervisors' Meeting on Tuesday, December 5, 2023.
8. The Board of Supervisors intends to make the appointment of the Pima County Board of Supervisors Member, District 3, at their meeting on Tuesday, December 19, 2023.
9. The person appointed will fill the remaining term and serve through December 31, 2024. District 3 voters will elect a candidate to serve a new four-year term at the General Election in November 2024.
