**Title:** Prism Sky Drive and Sun Splash Drive Yield Ordinance

### **Introduction/Background:**

The Pima County Traffic Engineering Division received a request from a citizen for the installation of a Stop or Yield sign at the intersection of Prism Sky Drive and Sun Splash Drive. Prism Sky Drive and Sun Splash Drive are both local roadways with a 25 mph speed limit.

### **Discussion:**

The Pima County Traffic Engineering Division conducted a sight visibility study at the four-legged intersection of Prism Sky Drive and Sun Splash Drive in response to the request.

### **Conclusion:**

The results of the sight visibility study determined that Yield control is warranted on Sun Splash Drive at Prism Sky Drive.

### **Recommendation:**

The Pima County Traffic Engineering Division recommends approval to designate the intersection of Prism Sky Drive and Sun Splash Drive as a yield intersection with traffic on Sun Splash Drive yielding right of way to traffic on Prism Sky Drive.

**ORDINANCE NO. 2016-\_\_**

**AN ORDINANCE OF THE PIMA COUNTY BOARD OF  
SUPERVISORS REGULATING TRAFFIC AT THE  
INTERSECTION OF PRISM SKY DRIVE AND SUN  
SPLASH DRIVE IN PIMA COUNTY, ARIZONA**

**WHEREAS**, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-855 as amended, to designate and establish yield intersections and to erect yield signs, and

**WHEREAS**, the Board of Supervisors of Pima County, Arizona, has determined that it is necessary for the protection and convenience of the traveling public of Pima County, Arizona, to establish the intersection of Prism Sky Drive and Sun Splash Drive as a yield intersection,

**THEREFORE, IT IS HEREBY ORDAINED** by the Board of Supervisors of Pima County, Arizona, that:

**SECTION 1.** The intersection of Prism Sky Drive and Sun Splash Drive be designated a yield intersection with traffic on Sun Splash Drive yielding right of way to traffic on Prism Sky Drive.

**SECTION 2.** All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

**SECTION 3.** This ordinance shall take effect when and to the extent that yield signs are posted on the intersecting streets.

**SECTION 4.** Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

**SECTION 5.** The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.


