This Amendment extends the termination date to 06/30/20 and is for a one-time increase in the amount of \$46,000.00 for a cumulative not-to-exceed contract amount of \$1,246,000.00. This increase is required for continued use of the Data Fiber Link between Data Centers for supporting critical systems and connectivity.

CONTRACT AMENDMENT

The parties agree to amend the above-referenced contract as follows:

1. **Background and Purpose.**
 - 1.1. Background. On 03/27/15, County and Cox Arizona Telcom, LLC ("Contractor") entered into the above referenced agreement to provide Data Fiber Link between Data Centers.
 - 1.2. Purpose. County requires continued use of the Data Fiber Link between Data Centers for supporting critical systems and connectivity.
 - 1.3. The parties agree to a retroactive effective date of March 26, 2020.
2. **Term.** The Contract terminates on 06/30/20.
3. **Maximum Payment Amount.** The maximum amount the County will spend under this Contract, as set forth in **Section 7, COMPENSATION & PAYMENT**, is increased by \$46,000.00. County's total payments to Contractor under this contract, including any sales taxes, will not exceed \$1,246,000.00.
4. **Israel Boycott Certification.** Pursuant to A.R.S. § 35-393.01, if Contractor engages in for-profit activity and has 10 or more employees, and if this Contract has a value of \$100,000.00 or more, Contractor certifies it is not currently engaged in, and agrees for the duration of this Contract to not engage in, a boycott of goods or services from Israel. This certification does not apply to a boycott prohibited by 50 U.S.C. § 4842 or a regulation issued pursuant to 50 U.S.C. § 4842.

The effective date of this Amendment is March 26, 2020.

All other provisions of the Contract not specifically changed by this Amendment remain in effect and are binding upon the parties.


