ITEM SUMMARY, JUSTIFICATION and/or SPECIAL CONSIDERATIONS:

ORDINANCE NO. 2013 - ___, An ordinance of the Pima County Board of Supervisors, establishing a pedestrian crosswalk on Flowing Wells Road in Pima County, Arizona. Staff recommends **APPROVAL**. (District 3)

The reason for this ordinance is to establish a pedestrian crosswalk on Flowing Wells Road to provide a safer and more visible crossing for the area's residents.

The Pima County Department of Transportation, Traffic Engineering Division, recently completed a safety and pedestrian study on Flowing Wells Road. The studies found a significant number of pedestrians crossing Flowing Wells Road in the vicinity of Wabash Street; SunTran bus ridership is also high for both the northbound and southbound stops in this area. Based on this study, it is recommended that a pedestrian crosswalk be installed on Flowing Wells Road approximately 50 feet north of Wabash Street.

**AN ORDINANCE OF THE PIMA COUNTY BOARD OF
SUPERVISORS ESTABLISHING A PEDESTRIAN
CROSSWALK ON FLOWING WELLS ROAD IN PIMA
COUNTY, ARIZONA**

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-791, as amended, to establish pedestrian crosswalks when needed to accommodate pedestrian traffic, and

WHEREAS, The Board of Supervisors of Pima County, Arizona, has determined that it is necessary for the protection of pedestrians to establish a crosswalk on Flowing Wells Road approximately 50 feet north of Wabash Street,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. A pedestrian crosswalk shall be established on Flowing Wells Road approximately 50 feet north of Wabash Street.

SECTION 2. All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take effect when and to the extent that the pedestrian crosswalk is installed on Flowing Wells Road approximately 50 feet north of Wabash Street.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.


