# AN ORDINANCE OF THE PIMA COUNTY BOARD OF SUPERVISORS, PIMA COUNTY, ARIZONA, RELATING TO FORENSIC SCIENCE CENTER, ESTABLISHING A FEE FOR ANTHROPOLOGIST SERVICES

Whereas, it is the intent of this Ordinance to clearly state the fee schedule for services provided by the Pima County Forensic Science Center which are intended to be in an amount sufficient to defray costs and to maintain a level of resources that is commensurate with demands for services; and

Whereas, on November 8, 2011, Pima County adopted Ordinance 2011-84, which revised fees for the Pima County Forensic Science Center services; and

Whereas, Pima County wishes to establish a fee for anthropologist services and restate the fee schedule for other Forensic Science Center Services.

## NOW THEREFORE BE IT ORDAINED BY THE PIMA COUNTY BOARD OF SUPERVISORS:

**Section 1**. Unless otherwise agreed and memorialized in an Intergovernmental Agreement, the following fee schedule is adopted for the Pima County Forensic Science Center:

- A. Procedures for counties other than Pima:
  - 1. Autopsies \$2,200 per autopsy.
  - Skeletal Remains \$1,950.00.
  - 3. External Examinations \$ 500.00 per examination.
  - 4. External Examinations with toxicology \$ 800.00 per examination.
  - 5. X-Ray Services \$ 75.00 per decedent (includes copies on CD).
- B. Cremation authorization \$30.00 per authorization.
- C. Body Storage Fees:
  - \$75.00 per day, 72 hours after notification body may be released.
  - \$75.00 per day for public fiduciary cases, 30 business days after notification body may be released.
- Pathologists or Anthropologists fees \$400.00 per hour plus travel and per diem.
- E. Autopsy Reports:
  - Commercial users \$125.00 for each report.

- 2. Non-commercial users - \$5.00 for each report. 3. Family Members, Health Care Providers (i.e. hospitals & physicians), Social Service Agencies, etc. - first report no charge. Copy Fees: 1. Tissue Slides - \$25.00 per slide. 2. Kodachrome slides - \$7.00 per slide. 3. Photographs: \$1.00 each print. Photographs and/or x-rays per CD: \$10.00 (1-5 photos and/or xrays); \$20.00 (6-10 photos or x-rays); and \$30.00 (10 or more photos and/or x-rays). 4. Copies for documents other than autopsy reports: \$0.25 per page photocopied. Document Copies on CD: \$10.00 (1-10 pages); \$20.00 (11-20
- pages); and \$30.00 (21 or more pages). Funeral Directors or the funeral establishment they are associated with will supply body bags to replace those in which they receive decedents.
- G. Body bags are to be of same type and quality as received. In lieu of this body bag exchange, the Funeral Director or funeral establishment may pay \$50.00 per body bag.
- Section 1 Paragraph D of Ordinance No. 2011-84 is repealed. Section 2.

  - 5. X-Ray Services \$ 75.00 per decedent (includes copies on CD).
- B. Cremation authorization \$30.00 per authorization.
- C. Body Storage Fees:
  - \$75.00 per day, 72 hours after notification body may be released.
  - 2. \$75.00 per day for public fiduciary cases, 30 business days after notification body may be released.
- D. Pathologists fees \$400.00 per hour plus travel and per diem.
- Pathologists or Anthropologists fees \$400.00 per hour plus travel and per diem.
