Requested Board Meeting Date: October 3, 2017

Title: Temporary Road Closure Resolution

Introduction/Background:

The reason for this resolution is that Brooksee, LLC has requested the temporary closure of portions of Sabino Canyon Park, General Hitchcock Highway, Catalina Highway, and Melpomene Way for the Revel Mount Lemmon Marathon and Half event on Sunday, November 12, 2017 from 3:00 A.M. to 2:00 P.M.

Discussion:

As a result of the request and traffic control plan review, Pima County Traffic Engineering recommends the temporary closure of portions of Sabino Canyon Park, General Hitchcock Highway, Catalina Highway, and Melpomene Way to enhance the safety of the Revel Mount Lemmon Marathon and Half event by reducing potential vehicular conflicts. Northbound and southbound traffic on General Hitchcock Highway will be facilitated by a pilot car system in coordination with the Pima County Sheriff's Department.

Conclusion:

Pima County Traffic Engineering recommends the temporary closure of portions of Sabino Canyon Park, General Hitchcock Highway, Catalina Highway, and Melpomene Way to enhance the safety of the Revel Mount Lemmon Marathon and Half event by reducing potential vehicular conflicts.

Recommendation:

Pima County Traffic Engineering recommends approval of this resolution to temporarily close portions of Sabino Canyon Park from Upper Goat Hill Road to General Hitchcock Highway, General Hitchcock Highway from Sabino Canyon Park to Catalina Highway, Catalina Highway from General Hitchcock Highway to Melpomene Way, and Melpomene Way from Catalina Highway to Limberlost Road on Sunday, November 12, 2017 from 3:00 A.M. to 2:00 P.M.

RESOLUTION OF THE PIMA COUNTY BOARD OF SUPERVISORS PERMITTING THE TEMPORARY CLOSURE OF PORTIONS OF SABINO CANYON PARK, GENERAL HITCHCOCK HIGHWAY, CATALINA HIGHWAY, AND MELPOMENE WAY IN PIMA COUNTY, ARIZONA, FOR THE REVEL MOUNT LEMMON MARATHON AND HALF ON SUNDAY NOVEMBER 12, 2017

WHEREAS, Brooksee, LLC is conducting marathon running events on Sunday, November 12, 2017, and

WHEREAS, Brooksee LLC has requested the temporary closure of portions of Sabino Canyon Park from Upper Goat Hill Road to General Hitchcock Highway, General Hitchcock Highway from Sabino Canyon Park to Catalina Highway, Catalina Highway from General Hitchcock Highway to Melpomene Way, and Melpomene Way from Catalina Highway to Limberlost Road from 3:00 A.M. to 2:00 P.M to facilitate this event, and

WHEREAS, the Pima County Board of Supervisors has determined that it will be necessary to permit the temporary closure of portions of Sabino Canyon Park from Upper Goat Hill Road to General Hitchcock Highway, General Hitchcock Highway from Sabino Canyon Park to Catalina Highway, Catalina Highway from General Hitchcock Highway to Melpomene Way, and Melpomene Way from Catalina Highway to Limberlost Road to support this event,

THEREFORE, IT IS HEREBY RESOLVED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. Portions of Sabino Canyon Park from Upper Goat Hill Road to General Hitchcock Highway, General Hitchcock Highway from Sabino Canyon Park to Catalina Highway, Catalina Highway from General Hitchcock Highway to Melpomene Way, and Melpomene Way from Catalina Highway to Limberlost Road shall be temporarily closed to public traffic on Sunday, November 12, 2017 from 3:00 A.M. to 2:00 P.M.

SECTION 2. All applicable County officers and employees are hereby authorized and directed to perform all acts necessary or desirable to give effect to this Resolution.


