Title: Temporary Road Closure Resolution

Introduction/Background:

The reason for this resolution is that Country Fair White Elephant, Inc. has requested the temporary closure of portions of La Canada Drive and Esperanza Boulevard for the Country Fair White Elephant Parade event on Saturday, October 28, 2017 from 8:30 A.M. to 1:00 P.M.

Discussion:

As a result of the request and traffic control plan review, Pima County Traffic Engineering recommends the temporary closure of portions of La Canada Drive and Esperanza Boulevard to enhance the safety of the Country Fair White Elephant Parade event by reducing potential vehicular conflicts.

Conclusion:

Pima County Traffic Engineering recommends the temporary closure of portions of La Canada Drive from San Ignacio to Calle Lecho, and Esperanza Boulevard from Camino Del Portillo to Interstate 19 to enhance the safety of the Country Fair White Elephant Parade event by reducing potential vehicular conflicts. A full road closure on La Canada Drive will be in effect from Paseo Del Prado/Calle De Las Casitas to Desert Bell Drive/La Cano and on Esperanza Boulevard from Las Yuccas to Paseo Pena.

Recommendation:

Pima County Traffic Engineering recommends approval of this resolution to temporarily close portions of La Canada Drive from San Ignacio to Calle Lecho and on Esperanza Boulevard from Camino Del Portillo to Interstate 19 on Saturday, October 28, 2017 from 8:30 A.M. to 1:00 P.M.

WHEREAS, the Pima County Board of Supervisors has determined that it will be necessary to permit the temporary closure of portions of La Canada Drive from San Ignacio to Calle Lecho and Esperanza Boulevard from Camino Del Portillo to Interstate 19 to support this event,

THEREFORE, IT IS HEREBY RESOLVED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. Portions of La Canada Drive from San Ignacio to Calle Lecho and Esperanza Boulevard from Camino Del Portillo to Interstate 19 shall be temporarily closed to public traffic on Saturday, October 28, 2017 from 8:30 A.M. to 1:00 P.M.




