ITEM SUMMARY, JUSTIFICATION &/or SPECIAL CONSIDERATIONS:

The Pima County Attorney's Office, Civil Division is submitting the attached contract amendment to the Board of Supervisors for approval of a needed increase in contract funding.

Attorney Ronna L. Fickbohm of the Law Firm of Slosser, Struse, Fickbohm, Marvel and Fletcher, P.L.C. has been providing legal services in the form of legal advice to the Pima County Board of Supervisors and, if needed, legal representation of the Pima County Public Fiduciary and the Board in connection with the claim filed by Ginger Rodgers Rappeport.

Amendment 03 will increase the contract funding amount by an additional \$100,000 to a total not-to-exceed amount \$250,000 to cover the anticipated cost of legal services provided by Ronna L. Fickbolm of Slosser, Struse, Fickbohm, Marvel and Fletcher, P.L.C.

The effective date of this Amendment shall be when signed by the parties.


All other provisions of the Contract, not specifically changed by this Amendment, shall remain in effect and be binding upon the parties.


