## **Annual Extension of Public Transit and Special Needs Transportation Services**

### Introduction

The attached June 7, 2016 Board of Supervisors agenda item is a one-year term extension of the Intergovernmental Agreement (IGA) between Pima County and the Regional Transportation Authority (RTA) for public transit and special needs transportation services. The RTA is the regional provider of transit services in Pima County and this IGA is the mechanism by which Pima County supports and funds this service. This includes fixed-route Suntran service, express and rural transit service, and special needs transportation services.

On August 3, 2010, the Board of Supervisors adopted Resolution and Order 2010-190, which approved an IGA between Pima County and the RTA for a period of five years. In Fiscal Year (FY) 2015/16, the Board approved the extension of this IGA for only one year because the City of Tucson and the RTA were considering changes to transit service to meet budget demands. This process is continuing. It is therefore recommended this IGA be extended for another one-year period. As regional transit service and funding become more stable and secure, a longer-term agreement with the RTA can be pursued.

Pima County's annual contribution for transit service is referred to as Maintenance of Effort (MOE) funding. The amount is based on A.R.S. §48-5308, which establishes the amount of funds spent in FY 2003/04 as the base amount, adjusted each subsequent year based on the percentage change in the Gross Domestic Product (GDP) price deflator. The GDP price deflator, as defined in A.R.S. §41-563, is a metric like the Consumer Price Index, which accounts for inflation. Section 4 of the IGA enables the County Administrator and the RTA Executive Director to calculate and approve the annual funding amount each year. In FY 2015/16, the inflation-adjusted amount was \$5,964,513. The proposed amount for FY 2016/17 is \$6,066,089, an increase of \$101,576.

If approved by the Board, this IGA extension will allow the RTA to continue to provide transit services in the unincorporated area of Pima County for FY 2016/17.

### Recommendation

I recommend the Board of Supervisors approve a one-year extension to the Intergovernmental Agreement between Pima County and the Regional Transportation Authority for public transit and special needs transportation services for Fiscal Year 2016/17.


