ITEM SUMMARY, JUSTIFICATION and/or SPECIAL CONSIDERATIONS:

ORDINANCE NO. 2014 - ___, An ordinance of the Pima County Board of Supervisors, regulating traffic at the intersection of Los Reales Road and Swan Road in Pima County, Arizona. Staff recommends **APPROVAL**. (District 2)

The reason for this ordinance is to designate Los Reales Road and Swan Road as a multi-way stop intersection.

A recent traffic study determined that, due to the continuing crash frequency of angle crashes, this intersection should be controlled by an all-way stop. The entering volumes and number of turning vehicles also support this type of traffic control.




Los Reales Road at Swan Road will be designated an all-way stop intersection and the proper traffic control devices will be installed.

**AN ORDINANCE OF THE PIMA COUNTY BOARD OF
SUPERVISORS REGULATING TRAFFIC AT THE
INTERSECTION OF LOS REALES ROAD AND SWAN
ROAD IN PIMA COUNTY, ARIZONA**

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-855, as amended, to designate stop intersections and to erect stop signs, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined that it is necessary for the protection and convenience of the traveling public of Pima County, Arizona, to designate the intersection of Los Reales Road and Swan Road as an all-way stop intersection,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. The intersection of Los Reales Road and Swan Road shall be designated as an all-way stop intersection.

SECTION 2. All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take effect when and to the extent that stop signs are posted on the intersecting roadways.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
