ITEM SUMMARY, JUSTIFICATION and/or SPECIAL CONSIDERATIONS:

ORDINANCE NO. 2013 - ___, An ordinance of the Pima County Board of Supervisors, regulating traffic at the intersection of Hildreth Avenue and Corona Road in Pima County, Arizona. Staff recommends **APPROVAL**. (District 5)

The reason for this ordinance is that the Pima County Department of Transportation, Traffic Engineering Division conducted a review of the intersection of Hildreth Avenue and Corona Road. This review indicated limited sight distance for northbound Hildreth Avenue at Corona Road. It is recommended that the intersection of Hildreth Avenue and Corona Road be designated as a stop intersection, with traffic on Hildreth Avenue stopping for traffic on Corona Road

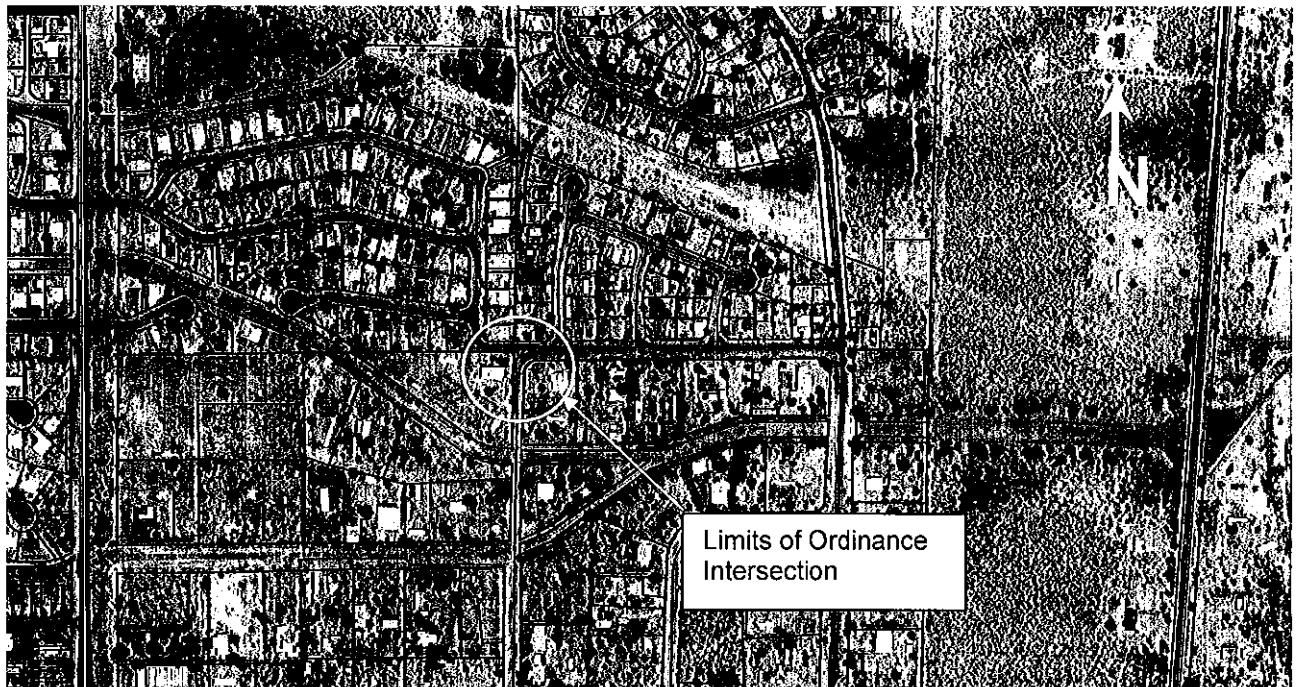

**AN ORDINANCE OF THE PIMA COUNTY BOARD OF
SUPERVISORS REGULATING TRAFFIC AT THE
INTERSECTION OF HILDRETH AVENUE AND
CORONA ROAD IN PIMA COUNTY, ARIZONA**

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-855 as amended, to designate and establish stop intersections and to erect stop signs, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined that it is necessary for the protection and convenience of the traveling public of Pima County, Arizona, to establish the intersection of Hildreth Avenue and Corona Road as a stop intersection,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. The intersection of Hildreth Avenue and Corona Road be designated a stop intersection with traffic on Hildreth Avenue stopping for traffic on Corona Road.

SECTION 2. All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take effect when and to the extent that stop or yield signs are posted on the intersecting streets.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.


