One Book, One Community

***Purpose:**

"One Book, One Community" will be a joint collaboration with the University of Arizona's School of Social and Behavioral Sciences, Tucson Unified School District's (TUSD) African-American Student Services, and the Dunbar Cultural Center to celebrate the Black community, diversity, and the Dunbar Cultural Center's 100th anniversary. "One Book, One Community" will involve distribution of copies of the title to members of the community at various locations including library branches and the Dunbar Cultural Center. Members of the community will participate in a community-wide read along which will involve programs and events taking place throughout the year.

***Program Goals/Predicted Outcomes:**

The One Book One Community Project will connect members of the African American community with each other and the library by creating programming and enhancing the collection for their needs and interests.

***Public Benefit:**

Young members of Pima County's African American community will benefit from exploring writers and book characters are diverse just like they are, encouraging a love of reading.

Program attendance, community feedback, staff observations and surveys will gauge youth's increased sense of inclusion and connection to the library.

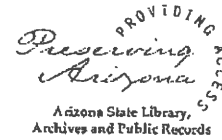
