1. **INVOCATION**

The Chairman requested that everyone observe a Moment of Silence in memory of the families in Oklahoma who had been affected by the devastating tornados.

2. **PLEDGE OF ALLEGIANCE**

All present joined in the Pledge of Allegiance.

3. **PAUSE 4 PAWS**

The Pima County Animal Care Center showcased an animal available for adoption.

4. **BOARD OF SUPERVISORS**

RESOLUTION NO. 2013 - 37 of the Board of Supervisors, requesting that the Arizona Legislature partially or fully return to Pima County the \$38 million in Highway User Revenue Funds that have been swept since 2002; pass legislation to maintain the one-cent per gallon excise tax previously earmarked for underground storage tank remediation and provide the estimated annual revenue of \$29 million from this tax to the state, cities, towns and counties for pavement repair and maintenance; increase the state gasoline tax by 10 cents; and pursue other mechanisms that increase funding for road preservation.

Chuck Huckelberry, County Administrator, stated the resolution memorialized the actions approved by the Board at their last meeting. He said an additional resolution would be developed for the 2014 Legislative Agenda and be brought back in the fall.

Supervisor Carroll stated he had received feedback regarding the proposed language for the increase of the gas tax by 10 cents and requested the resolution be amended to read, "up to 10 cents." He asked that the resolution be shared at the Western Region Meeting of the National Association of Counties.

Supervisor Miller stated an increase in the gas tax will affect those who can least afford it and that this was not a solution.

Robert Black addressed the Board regarding the impact to the general public by the tax increase and asked if the extra revenue would be allocated to road improvements.

Mr. Huckelberry provided an overview of the funding and expenditures for the Department of Transportation.

It was moved by Supervisor Elías and seconded by Supervisor Bronson to adopt the Resolution as amended with the language to read, "up to 10 cents." Upon roll call, the motion carried by a 4-1 vote, Supervisor Miller voted "Nay."

5. **TENTATIVE BUDGET HEARING**

Chuck Huckelberry, County Administrator, reported on the recommended tentative budget and explained it would set the expenditure ceiling for Fiscal Year 2013-2014.

Supervisor Miller stated the County had not yet challenged Department Directors to reduce spending. She believed that having a Communications Department was not a necessity and disagreed with the continued subsidy for the UA Medical Center South Campus, the Stadium District and Tucson Regional Economic Opportunities (TREO) organization. She stated the County had not protected taxpayers as it continued to enter into contracts without satisfactory terms, conditions and termination clauses citing the examples of the Joint Justice Complex and the Office of Emergency Management and Homeland Security. She said she had not had the opportunity to review the \$27 million requested for non-medical professional consultants. She stated the County continued to allow the infrastructure to decay and that the number one complaint received by her constituents was the poor condition of the roads. She felt the employees continued to be shortchanged and that the County invested thousands in training only to have employees move on to other municipalities for better wages. She believed the Supervisors should have an open discussion to adequately review the budget recommendations, that the budgets should be built from the bottom up and that the departments should have performance measures to ensure accountability. Supervisor Miller stated she would not be supporting any of the County budgets.

Supervisor Elías stated he believed Pima County had been one of the more responsible local governments in the State of Arizona, that difficult decisions had been made and more would be ahead with the most difficult decisions being those

about our employees. He stated the County had maintained a fund balance that protected the citizens of the County and had absorbed the losses which occurred last fiscal year with the historic drop in property values.

Supervisor Carroll stated he would support as a priority in the budget the 1% cost of living increase for employees starting July 2013 and the 2% to begin January 2014; the doubling of the road repair allocation from the General Fund from \$5 million to \$10 million; and the funding for law enforcement and the Sheriff's compression issue. He said he appreciated the efforts of the County Administrator but he would oppose any tax rate increase that would be recommended.

The Chairman inquired whether anyone wished to address the Board. The following individuals addressed the Board during the Tentative Budget Hearing:

Judge Kenneth Lee, Superior Court, appeared on the behalf of Presiding Judge Sarah Simmons and asked that the supplemental package regarding compensation for probation officers, surveillance officers and juvenile detention officers be approved.

Kent Batty, Superior Court Administrator, stated employee compensation needed to be one of the County's highest priorities as the County was not competitive in the market.

Judge Karen Adam, Juvenile Court, stated there was a decrease in delinquency, but an increase in child welfare cases. She explained that several new programs were dependent upon bed counts which the court system endeavored to reduce and therefore the court system would not be receiving additional monies. She asked that the supplemental package discussed by Judge Lee be approved.

Stephen Rubin, Juvenile Court Administrator, supported approval of the supplemental package to fund the court officers and stated that the courts were losing employees to other entities because the County was not competitive with market salaries. He stated the State systems unfortunately did not reward for success, only for capacity.

Terry B. Parish, Deputy Sheriff, spoke on behalf of the Deputy's Association and the Fraternal Order of Police. He explained that other organizations were actively recruiting our deputies and that the salaries needed to be decompressed to retain officers.

Catalina Campos Llamas, Pima County Adult Education Graduate, asked for continued support of the Adult Education Program and invited the Board to the graduation ceremony.

Robert Black stated that the per capita spending by Pima County was higher than other entities and that the County was inefficient when it came to budgeting.

Caleb Rhodes spoke about the lack of job opportunities for college graduates in Pima County, opposition to proposed tax increases and that Pima County needed to promote business.

Dan Alustiza stated property taxes were currently high and should not be raised.

Maya Castillo, President of the Local Service Employees International Union, stated other compensation alternatives should be offered to employees that would be sustainable rather than providing employees with a one-time sum.

6. **BOARD OF SUPERVISORS**

Review and adoption of the Tentative County Budget for Fiscal Year 2013/2014.

Chuck Huckelberry, County Administrator, provided an overview of the recommended budget and explained it had been prepared as a maintenance budget. Departments had reduced their budgets from 12-15% over the past four years and further reductions would mean impacts to services. He explained the proposed budget would not increase property taxes as the rates had been adjusted to offset the reduction of property values.

Supervisor Bronson thanked staff for their efforts in compiling the budget in a comprehensive and comprehensible format. She stated she had concern over the compression issue with salaries and commented that while Pima County's property tax may be somewhat higher than other jurisdictions, the overall tax burden to the residents in other counties was about equal when sales taxes and the imposition of secondary tax levies were factored into the equation.

Supervisor Elías stated this year a much needed review of the different divisions within the Health Department was accomplished and was now reflected in this budget. He said the money allocated to the South Campus of the University Health Center would be well spent and that the issues raised regarding employee salaries be seriously considered as the Board moved toward final budget.

Supervisor Carroll stated these had been difficult economic times and he appreciated the efforts which had been made, however he would not be in support of the budget, as presented.

Chairman Valadez stated there had been an historic decrease to property values in Pima County and felt the Board had been responsive to the situations that had been created.

It was moved by Supervisor Bronson and seconded by Supervisor Elías, to close the public hearing and adopt the Tentative County Budget in the amount of \$1,270,063,686.00 with an effective tax rate of \$3.71, which would allow the Board to continue the discussion regarding transportation needs, compensation and

compression issues in justice and law enforcement. Upon roll call, the motion carried by a 3-2 vote, Supervisors Carroll and Miller voted "Nay."

7. **BOARD OF SUPERVISORS**

Review and adoption of the Debt Service Tentative Budget for Fiscal Year 2013/2014.

It was moved by Supervisor Bronson and seconded by Supervisor Elías, to close the public hearing and adopt the Debt Service Tentative Budget in the amount of \$124,043,471.00 for an effective tax rate of \$0.7800. Upon roll call, the motion carried by a 3-2 vote, Supervisors Carroll and Miller voted "Nay."

Without objection, the item was removed from the agenda.

Mark Finchem addressed the Board and stated the County had gone too far above the buyer's appraised value and the action would increase surrounding property values.

Supervisor Miller questioned the contract amount and the need to purchase the property.

It was moved by Supervisor Bronson, seconded by Supervisor Elías and carried by a 4-1 vote, Supervisor Miller voted "Nay," to approve the item.

10. Fireworks Permit

The Chairman inquired whether anyone wished to address the Board. No one appeared. It was moved by Supervisor Bronson, seconded by Supervisor Carroll and unanimously carried by a 5-0 vote, to close the public hearing and approve the permit.

Randy D. Nations, Hot Rods Old Vail, 10500 E. Old Vail Road, Vail, Temporary Extension of Premises for July 4, 11, and 18, 2013.

The Chairman inquired whether anyone wished to address the Board. No one appeared. It was moved by Supervisor Bronson, seconded by Supervisor Carroll and unanimously carried by a 5-0 vote, to close the public hearing, approve the permit and forward the recommendation to the Arizona Department of Liquor Licenses and Control.

12. Plat Note Modification

P1209-010, CHULA VISTA, LOT 6

Request of Frank and Melinda Simpson, for a plat note modification to allow use of designated natural open space for an extended yard area and fence. The applicant proposes to designate an equal amount of undisturbed area in exchange for undisturbed, platted, natural open space on Lot 6 of the Chula Vista Subdivision Plat as recorded at Bk .64, Pg. 90. The subject site is zoned CR-1 (Single Family Residence) and is approximately 0.98 acres. Staff recommends APPROVAL WITH CONDITIONS. (District 1)

The Chairman inquired whether anyone wished to address the Board.

Todd Vanderah, owner in the Chula Vista Subdivision, requested clarification on the changes which were proposed and stated this would impact the open space between where the residences would be built.

Arlan Colton, Planning Director, explained the shift in the designation of natural open space and stated property owners had the option to request a plat note modification.

It was moved by Supervisor Miller, seconded by Supervisor Bronson and unanimously carried by a 5-0 vote, to close the public hearing and approve P1209-010, for a plat note modification.

13. **Traffic Ordinance**

The Chairman inquired whether anyone wished to address the Board. No one appeared. It was moved by Supervisor Bronson, seconded by Supervisor Elías and unanimously carried by a 5-0 vote, to close the public hearing and adopt the Ordinance.
