Introduction / Background: At a regularly scheduled Board of Supervisors meeting held on January 10, 2012 the

Board voted on Resolution 2012-4 that gives the County Administrator the authority to execute any such subordinations or releases of restrictive covenants on behalf of Pima County. Additionally, the County Administrator was authorized to appoint a designee to execute these documents on his behalf. Community and Workforce Development did not exist as a department as it does today when this resolution was passed. As the successor department to Community Development and Neighborhood Conservation Department, we request an update to the resolution to

authorize the County Administrator to designate the director of Community and

Workforce Development as an authorized signer.

**Discussion:** The Pima County Community and Workforce Development Department manages

certain HUD funded programs that require grant funds be secured by recorded and restrictive covenants. Similarly, the Gap Funding for Affordable Housing Program requires the execution of subordination agreements, and the recording of restrictive covenants. RESOLUTION OF THE PIMA COUNTY BOARD OF SUPERVISORS AUTHORIZING THE COUNTY ADMINISTRATOR OR DESIGNEE TO EXECUTE DOCUMENTS, INCLUDING, BUT NOT LIMITED TO, SUBORDINATION AGREEMENTS AND/OR DEEDS OF RELEASE AND RECONVEYANCE, RELATED TO RESTRICTIVE COVENANTS ON AFFORDABLE HOUSING AND COMMUNITY DEVELOPMENT TRANSACTIONS FINANCED BY OR THROUGH PIMA COUNTY.

## The Board of Supervisors of Pima County, Arizona finds:

- The Community and Workforce Development Department administers several federal and local programs, including the Gap Funding for Affordable Housing and Community Development Block Grant projects, to construct or rehabilitate affordable housing, improve communities, and help low- and moderate-income households purchase or retain affordable housing.
- 2. The assistance provided under these programs is secured by recorded restrictive covenants.
- During the term of such restrictions it may be necessary to enter into subordination agreements and/or to release such restrictions via subordination of lien agreements and deeds of release and reconveyance.
- 4. The execution of any such subordinations or releases of restrictive covenants is time critical to ensure that closings for purchase of or refinancing for affordable housing under County's Affordable Housing Programs are not negatively impacted.
- There is no significant benefit to retaining such housing related documents in the Pima County Central Contract Repository, because these documents are recorded and readily accessible through the Pima County Recorder.
- 6. The execution of these documents is administrative in nature.
- 7. It is deemed to be in the public interest to authorize the County Administrator or designee to execute such documents on behalf of Pima County,
- 8. In 2012, the Board of Supervisors adopted Resolution 2012-4, authorizing the County Administrator or designee to "execute documents, including, but not limited to, subordination agreements and/or deeds of release and reconveyance, related to restrictive covenants on affordable housing transactions financed by or through Pima County."
- On January 31, 2012, the County Administrator designated the Deputy County Administrator for Community and Economic Development and Director of Community Development and Neighborhood Conservation Department as designees under Resolution 2012-4.

10. The Community Development and Neighborhood Conservation Department has since merged into Community and Workforce Development.

**NOW, THEREFORE, BE IT RESOLVED,** that the County Administrator or designee be and is hereby authorized to execute documents, including, but not limited to, subordination agreements and/or deeds of release and reconveyance, related to restrictive covenants on affordable housing transactions financed by or through Pima County,
