Requested Board Meeting Date: Nov. 5, 2013

ITEM SUMMARY, JUSTIFICATION &/or SPECIAL CONSIDERATIONS:

This Intergovernmental Agreement (IGA) between Pima County and the Arizona Health Care Cost Containment System (AHCCCS) will continue a system through which the Title XIX AHCCCS eligibility for individuals incarcerated at Pima County Adult Detention Complex (PCADC) will be suspended during their incarceration and immediately reinstated upon release from the jail. AHCCCS member data will be matched with PCADC booking and release data daily. Amendment #1 to this IGA extends the term from 6/30/2013 to 6/30/2017.

No additional technology or financing is required and each party will bear the cost of performing its responsibilities. AHCCCS will utilize the information Pima County provides to suspend capitation payments to AHCCCS health plans for PCADC detainees and thereby abide by federal mandates that prohibit Medicaid payments for incarcerated people. Pima County and its health services and eligibility vendors will use the information to improve discharge planning which is a requirement of accreditation for health services to detainees.
