### \*Purpose:

A Memorandum of Agreement (MOA) for the scoping phase and Funds Transfer Agreement (FTA) were approved at the August 17, 2020 BOS meeting for \$10,000 in local matching funds. A MOA for the final design and construction phase and Modification 001 to the FTA was approved at the August 19, 2021 BOS meeting for \$305,000 in matching funds, which was 5.7% of the total project cost of \$5,500,000. Modification 001 to the final design and construction phase MOA and Modification 002 to the FTA are necessary due to rising costs. The total project cost is now estimated at \$8,770,000, which will increase the 5.7% match amount by \$185,000 to \$500,000 total. The anticipated year of construction is FY 24/25, subject to available Central Federal Lands Highway Division (CFLHD) funding. The original Grant Number was 21\*009. CT-TR-21\*196 was created for the FTA.

#### \*Procurement Method:

This Grant Agreement was reviewed and signed by the Pima County Attorney's Office.

#### \*Program Goals/Predicted Outcomes:

The goal of the project is to improve access to USFS lands by rehabilitating and paving 0.4 miles of Sabino Canyon Park Road, constructing a new 75 stall parking lot and 21 on-street parking stalls, 5' wide shared-use path and a public restroom.

#### \*Public Benefit:

This improvement will mitigate congestion and improve safety on Sabino Canyon Park Road by providing much needed additional parking for visitors seeking recreational activities on USFS lands below Summerhaven.

#### \*Metrics Available to Measure Performance:

The performance will be measured by successful delivery of the project improvements under consideration.

### A. PURPOSE OF THIS AGREEMENT

This Agreement documents the intent of the parties and sets forth the anticipated responsibilities of each party in the development, construction, and future maintenance of the subject project. The purpose of the Agreement is to identify and assign responsibilities for the environmental review, design, right-of-way, utilities, acquisition and construction as appropriate for this programmed project, and to ensure maintenance of the facility for public use if improvements are made. The parties understand that any final decision as to design or construction will not be made until after the environmental analysis required under the National Environmental Policy Act (NEPA) is completed (this does not prevent the parties from assigning proposed design criteria to be studied in the environmental review process.) Any decision to proceed with the design and construction of the project will depend on the availability of appropriations at the time of obligation and other factors, such as issues raised during the environmental review process, a natural disaster that changes the need for the project, a change in Congressional direction, or other relevant factors.

If Federal Lands Access Program funds are used for the development or construction of this project, Pima County agrees to provide a matching share equal at least 5.7% of the total cost of the project, as detailed more fully in Sections J and K below.

## **B. AUTHORITY**

This Agreement is entered into between the signatory parties pursuant to the provisions of 23 U.S.C. 204.

#### C. JURISDICTION AND MAINTENANCE COMMITMENT

The Pima County has jurisdictional authority to operate and maintain the existing facility and will operate and maintain the completed project at its expense.

#### D. FEDERAL LAND MANAGEMENT AGENCY COORDINATION


The Pima County has coordinated project development with the USFS. The USFS support of the project is documented in the Arizona Federal Lands Access Program Project Application for this project submitted by Pima County to FHWA-CFLHD. Each party to this agreement that has a primary role in the environmental review process, design, or construction shall coordinate their activities with the USFS.

## E. PROJECT BACKGROUND/SCOPE

<u>General Project Description</u>: Sabino Canyon Park Road, also known as Forest Road 510, is located within Pima County, Arizona, north of Tucson, Arizona. The project begins on the north at the intersection with Carter Canyon Road and ends at the Forest Service gate. The project length is approximately 0.5 miles.

This project includes the construction of a new paved parking lot consisting of 75 parking spaces, a kiosk for Arizona Trail information, a public restroom, and the improvement of Sabino Canyon Park Road to accommodate 21 new on-street parking spaces, an asphalt surface rehabilitation for approximately half a mile, and the installation of a 5-foot-wide pathway as part of the non-wilderness bypass of the Arizona Trail. The project improvements will provide a new paved surface, roadway excavation, tree clearing, ditch construction/reconditioning to improve drainage, installation of culverts, a new public bathroom, and the installation of new street signage and pavement marking.

The need for the project has been described by Pima County as stemming from the inadequacy of the existing parking and high levels of congestion at the Marshall Gulch Trailhead as documented in the Summerhaven Congestion Management Concepts Study. Improving pedestrian access and alleviating congestion will improve pedestrian safety.

Environmental Compliance and Permitting: FHWA-CFLHD will be the lead agency for the environmental review process. It is anticipated that a biological survey, including wetland delineation and habitat surveys, will be required. A cultural resource survey also will be needed. The project area is located in Mexican Spotted Owl (MSO) critical habitat. Protected Activity Centers (PACs) are located outside of the project area. No threatened and endangered species (T&E) surveys for the MSO or other species will be performed. Without performing these T&E surveys, construction noise restrictions will be in place based on MSO nesting times, currently from March 1 to August 30. Construction during the MSO nesting times would be restricted to activities that do not exceed 69 dBA more than twice per hour or for more than one hour. If it is desired that T&E surveys for the MSO be completed, these would need to be performed following approved protocol including surveying for one night eight separate times over a two-year period, during the nesting season, prior to construction and would be at an additional cost to what has been identified in this

scoping document. If MSO are not detected during approved-protocol surveys in a PAC during the nesting season, restrictions on noise disturbances may be relaxed depending on the nature and extent of the proposed disturbance. A Biological Evaluation will be prepared. A Biological Assessment to meet U.S. Fish and Wildlife Service (USFWS) requirements may be needed depending on the outcome of the biological survey. The anticipated National Environmental Policy Act (NEPA) compliance document is a Categorical Exclusion (CE). No public scoping activities will be required.

This project is located on the Arizona Trail non-wilderness bypass corridor. The project may impact the Faul Recreation Area (owned by the University of Arizona). The project may qualify for a transportation exception. A Special Use Permit may be required from the USFS. The project may require fill placement into Sabino Creek, which is likely a jurisdictional Water of the U.S. (WOUS). It is anticipated the project will be permitted under a Clean Water Act, Section 404 Nationwide Permit.

The disturbance area is anticipated to be greater than 1 acre; as a result, a National Pollutant Discharge Elimination System (NPDES) Permit will be required. The project approach will be to prepare a high-level stormwater pollution prevention plan and require the Contractor to finalize and hold the permit.

<u>Survey</u>: Topographic survey will be acquired using electronic total station methods due to the thick canopy of trees within the project limits. Limits of survey will include approximately 50 feet on either side of the existing roadway alignment. Also included in the survey will be the proposed parking area terrain so earthwork can be calculated more accurately for the project.

## Highway Design and Safety:

**Typical Section and Alignment:** The existing width of pavement varies from 20 feet to 24 feet. The proposed roadway width is 24 feet, consisting of two 11-foot lanes and 1-foot shoulders on each side. In addition, a 5-foot minimum sidewalk is proposed on the west side. The roadway alignment may shift to the east at the south end of the project to avoid cutting into a large granite outcropping to the west. Vertical alignments will remain the same, with the exception of the low water crossing that will be converted to a culvert crossing. Crown corrections are being considered to aid in the drainage design.

**Other:** A 75-space parking lot is proposed to the west of the road in a wooded area and 21 on-street parking spaces also will be formalized.

**Safety and Design Exceptions:** Guardrail will be added in locations where there is a significant drop off to the creek within the clear zone. Signing and pavement markings will be updated to current *Manual on Uniform Traffic Control Devices* (MUTCD) standards to increase safety. No significant highway design exceptions are anticipated.

<u>Pavement Design</u>: The preliminary pavement recommendation is 3 inches of HACP over 6 inches of pulverized base material. FHWA-CFLHD will perform a pavement investigation to determine the final pavement design.

<u>Structure/Bridge Design</u>: There are no existing structures on Sabino Canyon Park Road. A retaining wall may be needed for grading to stay within the existing County ROW behind the proposed public restroom facility. Anticipated wall height is between 8 feet and 10 feet and approximately 60 feet long.

<u>Geotechnical</u>: The geotechnical evaluation will address improvements for rehabilitating about 0.5 mile of road, adding a new 75-space parking lot in an undeveloped/wooded area adjacent to the road, a proposed retaining wall at the restroom facility, and replacing the failed and distressed wire-faced retaining wall along the creek.

<u>Hydrology/Hydraulics</u>: Along the project corridor, there are a total of five water crossings. These crossings consist of three culvert locations, one inlet (combination) location, and one low water crossing (LWC) location. At each of the locations, there is evidence of scouring and debris accumulation. Proposed improvements recommend removing and replacing all five existing crossing locations, along with providing headwalls or flared end sections and riprap aprons. Conceptual sizing of the culverts includes:

- 24-inch corrugated metal pipe (CMP) at four locations (two existing 18-inch pipes, one existing 24-inch pipe, and one existing inlet)
- 3 barrels of 30-inch equivalent diameter CMP at the existing LWC location

Because of roadway widening, there may be minor impacts along 400 feet of a tributary of Sabino Creek. It is anticipated that equivalent conveyance geometry will be provided (maintaining the width of the creek so that flows are not impacted) in the Sabino Creek channel which will remove the need for floodplain modeling.

Right of Way: Pima County has existing right of way (ROW) from the north end of the project south to the proposed entrance to the parking lot at the USFS boundary. The width of the existing ROW varies in this segment of road. South of the USFS boundary, there is no existing ROW. The County maintains this road up to the USFS gate. This project will further formalize the County's maintenance responsibilities by creating a highway easement deed for the road and the parking lot in the USFS property.

<u>Utilities</u>: Known utilities in the project area include water, sewer, and overhead electric. This project includes providing new utility connections for the proposed public restroom just north of the water treatment plant. In addition, any existing manhole or valve covers in the existing roadway would be adjusted to the new finished grade.

<u>Construction</u>: At this time, it is anticipated this project will need to be constructed outside the nesting season for the MSO or adhere to the noise restrictions if construction activities do occur within the nesting season. Anticipated construction season to avoid these noise restrictions is September 1 through February. This location does receive occasional snow during these months but delays due to snow are not anticipated to be longer than a few days. Due to the remote nature of this road, hauls for construction materials could be approximately two hours one way. The partners have noted that at least a portion of the road could be closed during construction to increase efficiency. Local access would need to be maintained for at least one private residence.
