SaludArte – Building a Culture of Health through Vaccine Equity		

### \*Purpose:

AFTSA will work with the Health Department to conduct activities related to the SaludArte project. SaludArte will be funded by three major federal grants. Though the effort will be unified through SaludArte as one cohesive project, the deliverables required and budgets offered by each grant will remain separate and distinct, to ensure compliance measures are met for each funding entity and the purview of each grant program.

Amendment #1 allows for a 6-month extension due to the no-cost extension awarded by the funders at Arizona Department of Health Services. The Vaccine Equity contributions to the SaludArte program include: targeted community engagement activities, community member recruitment, and facilitation of community meetings to inform art production. No additional funding is obligated and programmatic activities for subrecipient will conclude by December 31, 2023.

#### \*Procurement Method:

This Subrecipient Agreement is a non-Procurement agreement and not subject to Procurement rules.

#### \*Program Goals/Predicted Outcomes:

Subrecipient will collaborate with Health Department staff and community-based partners to develop and implement a project work plan to document and interpret the lived experience of selected communities through Human Centered Design experiences, visual note taking and digital storytelling. Subrecipient will also work with staff and partners to increase access, acceptability and use of public health information and services by minority populations. Subrecipient will implement project plans for the SaludArte project with the Health Department and communities of focus as identified by the Work Plan, in conjunction with artists that represent those communities.

#### \*Public Benefit:

Subrecipient will provide a platform for communities disproportionately affected by communicable disease outbreaks to share their stories and process their experiences through collaboration and artistic inquiry. Subrecipient will identify and execute strategies and solutions to improve community responses to public health strategies for communicable disease prevention and increasing cultural health.

#### SUBRECIPIENT AGREEMENT AMENDMENT

The parties agree to amend the above-referenced contract as follows:

## 1. Background and Purpose.

- 1.1. <u>Background</u>. On August 2, 2022, County and Subrecipient entered into the above referenced agreement to provide community advisory services for the Building a Culture of Health through Vaccine Equity Project.
- 1.2. Purpose. County requires additional time to complete the revised Scope of Services.
- 2. Term. The County is exercising the first extension option to renew the Agreement for six additional months commencing on July 1, 2023 and terminating on December 31, 2023. If the commencement date is before the Effective Date of this amendment, the parties will, for all purposes, deem the amendment to have been in effect as of the commencement date.
- 3. Scope of Services. The parties have revised the Scope of Services as described in the attached Exhibit A.1 (2 pages).
- 4. Compensation. The revised budget can be seen in Exhibit B.1 (1 page).
- 5. Forced Labor of Ethnic Uyghurs. Pursuant to A.R.S. § 35-394, if Contractor engages in forprofit activity and has 10 or more employees, Contractor certifies it is not currently using, and agrees for the duration of this Contract to not use (1) the forced labor of ethnic Uyghurs in the People's Republic of China; (2) any goods or services produced by the forced labor of ethnic Uyghurs in the People's Republic of China; and (3) any contractors, subcontractors or suppliers that use the forced labor or any goods or services produced by the forced labor of ethnic Uyghurs in the People's Republic of China. If Contractor becomes aware during the term of the Contract that the Company is not in compliance with A.R.S. § 35-394, Contractor must notify the County

within five business days and provide a written certification to County regarding compliance within one hundred eighty days.

All other provisions of the Agreement not specifically changed by this Amendment remain in effect and are binding upon the parties.

## Exhibit A.1 (2 pages) Scope of Services

Subrecipient will work with Pima County Health Department (PCHD) to conduct activities related to the project *SaludArte*, funded by three grants the PCHD received related to health equity and the COVID-19 pandemic. The grants included are Advancing Health Literacy from the Health and Human Services Office of Minority Health, Health Disparities funded by the Centers for Disease Control and Prevention (CDC), and the Vaccine Equity grant funded by the CDC and passed through the Arizona Department of Health Services.

Within the context of this agreement, the subrecipient will be responsible for SaludArte's community engagement efforts (in conjunction with Pima County Communications Department), partnering with other jurisdictions and community-based organizations to host community engagement events with each of the identified communities of focus. The focus of the Vaccine Equity funding is to improve COVID-19 vaccination equity in hardest-to-reach populations and communities. To do this, the subrecipient will work with the Human Centered Design (HCD) leads to coordinate activities with five different communities (one in each supervisory district). Activities will include creating and implementing a storytelling communications plan, with the goal of improving COVID-19 mitigation and vaccine uptake by increasing communication between community members and vaccine providers and other organizations involved in vaccine efforts.

### **Tasks**

#### Subrecipient will:

- 1. Develop the Work Plan with PCHD staff as it pertains to *SaludArte* activities for the 2022 2023 project period. Due 30 days after Agreement is fully executed.
- Participate in and contribute to weekly SaludArte meetings to coordinate and execute the Work Plan, including meetings with PCHD staff and the Community Advisory Committee to identify and implement engagement among communities of focus.
- Work with each Supervisory District office, trusted community leaders, coalitions, and groups to select and recruit community member facilitators.
- 4. Organize community engagement efforts including, but not limited to:
  - a. Arrange at least four focus group meetings for each of the five communities of focus (i.e. storytelling listening sessions, Human Centered Design sprints, etc.), capturing community members' ideas and translating them into guidelines and inspiration for artists.
  - b. Identify Human-centered Design lead to conduct design sprints at up to two of the four meetings for each community of focus.

- c. Provide incentives to community member participants and select panel members.
- d. Procure childcare as needed for any/all meetings.
- 5. Coordinate with PCHD staff to ensure COVID-19 vaccine providers are present at community listening sessions and engagement events, as well as coordinate the provision of home testing kits and other COVID-19 mitigation supplies and materials to community members.
- 6. Submit monthly activity / progress reports and invoices to the Pima County Finance Office for payment using the form developed with Pima County.
- 7. Submit end of project summary report.

## Due Date(s)

Monthly Reports: Due the 15th of each month for the previous month. End of project summary report: Due December 31, 2023.

## 1. Compensation

County will reimburse subrecipient's expenses in accordance with the budget set forth below. Invoices submitted with monthly reports must contain adequate supporting documentation to verify the amount and nature of expenditures. Invoices shall be submitted to the County no later than the 15th of the month following the end of the month being invoiced for. County will pay invoices no later than 30 days from receipt of invoice and monthly report. County reserves the right to audit Subrecipient's financial records as relates to the performance of duties under this Agreement.
