Title: Traffic Regulation - Arbor Ridge Drive and Belltower Drive

Introduction/Background:

The Pima County Department of Transportation received an internal request to evaluate the need for the existing stop sign for Arbor Ridge Drive at Belltower Drive in Green Valley. Arbor Ridge Drive and Belltower Drive are both local roadways with a 25 mph posted speed limit. Arbor Ridge Drive terminates at Belltower Drive at the west end.

Discussion:

The Pima County Department of Transportation conducted a traffic control study at the Arbor Ridge Drive and Belltower Drive intersection to determine if the stop sign is recommended to remain. No sight limitations were observed at the intersection and there were no reported crashes in the past five years from 2015-2019.

Conclusion:

The traffic control study determined that the stop sign is recommended to remain for westbound Arbor Ridge Drive at Belltower Drive based on driver expectancy of the traffic control condition, and no crashes reported during the study period. A database review determined that there is not an existing ordinance to regulate the stop sign at the intersection.

Recommendation:

The Pima County Department of Transportation recommends the existing stop sign remain and an ordinance be approved to designate the intersection of Arbor Ridge Drive and Belltower Drive as a stop intersection with westbound traffic on Arbor Ridge Drive stopping for traffic on Belltower Drive.

ORDINANCE 2020 - _____

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, RELATING TO TRAFFIC AND HIGHWAYS; REGULATING TRAFFIC AT THE INTERSECTION OF ARBOR RIDGE DRIVE AND BELLTOWER DRIVE IN PIMA COUNTY, ARIZONA

THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA FINDS THAT:

1. The Board of Supervisors of Pima County, Arizona has authority under A.R.S. §§ 28-627 and 28-855 as amended, to designate and establish stop intersections and to erect stop signs.
2. The Board of Supervisors has determined that it is in the interest of public safety to establish the intersection of Arbor Ridge Drive and Belltower Drive as a stop intersection in Pima County, Arizona.

BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA:

SECTION 1. The intersection of Arbor Ridge Drive and Belltower Drive shall be designated a stop intersection with westbound traffic on Arbor Ridge Drive stopping for traffic on Belltower Drive.

SECTION 2. All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take into effect when and to the extent that stop signs are posted on the intersecting streets.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
