Your Message	<p>Dear Supervisors,</p> <p>I live in district 1 but the topic I'm writing about is so large that I felt it important to contact all of you. I absolutely oppose Project Blue, the massive data center complex proposed near the county fair grounds. I lived for many years in Chandler where we had to work with the City Council in the fight to limit the construction of data centers within that city's limits. The reasoning was clear after the first data center was built: data centers use enormous amounts of land, water and electrical power and yield very few jobs. Pima County will suffer the same consequences if Project Blue is allowed to go forward. Although details available to the public are sketchy at this point, the amount of water and electrical power that Project Blue will consume are so significant, that it will dampen this county's ability to lure other economic opportunities to the area due to lack of available resources.
