**\*Project Title/Description:**

This First Amendment to Operating Agreement assigns the rights and responsibilities of Cenpatico of Arizona, Inc., an Arizona corporation d/b/a Cenpatico Integrated Care to Health Net Access, Inc. d/b/a Arizona Complete Health - Complete Care Plan and extends the term for an additional two (2) to September 30, 2020.

**\*Purpose:**

The First Amendment to the Operating Agreement will allow Health Net Access, Inc. d/b/a Arizona Complete Health - Complete Care Plan to assume the rights and obligations as the Regional Behavioral Health Authority (RHBA) for southern Arizona designated by the State of Arizona from Cenpatico to operate the Crisis Response Center, which is owned by Pima County. The Arizona Health Care Cost Containment System is aware that Cenpatico will assign RBHA Title XIX/XXI contract #YH17-0001 and RBHA Non-Title XIX/XXI contract #YH17-0003 to Health Net Access effective October 1, 2018. The inventory of furnishings and the report requirements have been updated as shown in Exhibits A and E respectfully.

**\*Procurement Method:**

Exempt per Section 11.04.020

**\*Program Goals/Predicted Outcomes:**

Health Net Access, as the RHBA for the southern Arizona geographic area, will continue to operate, or subcontract with a third party, to operate the Crisis Response Center. The first floor contains a psychiatric urgent care crisis center for both adults and youths in separate areas and a sub-acute behavioral health in-patient facility and 24/7 call center are located on the second floor.

**\*Public Benefit:**

The southern Arizona community will benefit from the psychiatric and behavioral health services that will continue to be offered at the Crisis Response Center. Services are provided to individuals regardless of their ability to pay.

**\*Metrics Available to Measure Performance:**

The continuing operation of the Crisis Response Center complies with the use of the 2006 voter approved General Obligation Bond Project CFM.BYSYUC.



#### **FIRST AMENDMENT TO OPERATING AGREEMENT**

1. **Background and Purpose.** Pima County (“County”) and Cenpatico of Arizona, Inc., an Arizona corporation d/b/a Cenpatico Integrated Care (“Cenpatico”) entered into an Operating Agreement (the “Agreement”), in which Cenpatico agreed to operate a County-owned psychiatric urgent care crisis center, sub-acute behavioral health in-patient facility and call center located at 2802 E. District Street (the “CRC”), commencing on October 1, 2015.
  - a. As permitted under Section 7.1.2 of the Agreement, Cenpatico has operated the CRC through its subcontractor, Banner Health, and has operated the call center through a contract with NurseWise, LP, staffing the call center 24 hours a day, 7 days a week. NurseWise, LP has merged into its affiliate Envolve PeopleCare, Inc., and is now known as Envolve PeopleCare, Inc. d/b/a Nursewise.
  - b. Cenpatico has assigned the AHCCCS Regional Behavioral Health Authority contract for Southern Arizona (the “RBHA Contract”) to Health Net Access, Inc. dba Arizona Complete Health -Complete Care Plan (“Health Net”) effective October 1, 2018 as required by AHCCCS. Health Net will serve as the designated Regional Behavioral Health Authority for this geographical area effective October 1, 2018.
2. **Assignment.** Cenpatico hereby assigns its rights and obligations under the Agreement to Health Net, and Health Net hereby assumes all of Cenpatico’s obligations under the Agreement, effective October 1, 2018. Pima County hereby consents to this assignment.
3. **Term Extension.** The Term of the Agreement, as set forth in Section 4 of the Agreement, ends September 30, 2018. The Term of the Agreement is hereby extended for an additional two (2) years to September 30, 2020.

4. Furniture, Fixtures & Equipment. The items listed on Exhibit A to this Amendment are no longer in the Premises and no longer a part of the "County-Owned Property" as listed in Exhibit A to the Agreement.
5. Reporting Requirements. Exhibit E to the Agreement is hereby replaced with the document attached to this Amendment labeled Exhibit E.
