

This BILL OF SALE (this "Agreement"), dated as of June 10, 2025 is by and among Widad International Enterprises Inc, an Arizona Corporation (Seller), and Giapooja LLC, an Arizona Limited Liability Company (Buyer).

RECITALS

- A. Seller and Buyer are parties to an Asset Purchase Agreement executed June 5, 2025 (the "Purchase Agreement"), pursuant to which, among other things, Buyer has agreed to purchase certain assets of Seller upon the terms and conditions specified therein.
- B. This Agreement is being executed and delivered in order to affect the transfer to Buyer of such assets as set forth in the Purchase Agreement.

AGREEMENTS

In consideration of the premises and the mutual covenants and agreements set forth in the Purchase Agreement, the parties hereby agree as follows:

- 1. <u>Definitions</u>. Capitalized terms used in this Agreement and not otherwise defined herein shall have the meaning ascribed thereto in the Purchase Agreement.
- 2. <u>Sale of Assets.</u> Seller, in accordance with and subject to the terms of the Purchase Agreement, hereby sells, conveys, assigns, transfers and delivers to Buyer, and Buyer, in accordance with and subject to the Purchase Agreement, hereby purchases and acquires from Seller, all of Seller's right, title and interest of every kind and nature, that certain business known as Family Food Store, presently located at 2100 W. Ruthrauff Road, Tucson, AZ 85705, including State of Arizona Liquor License #09100156 and that certain equipment per the attached Exhibit "A", which exhibit is incorporated herein by reference. Seller further agrees to warrant and defend same against the lawful claims and demands of all persons whomsoever.
- 3. <u>Counterparts</u>. This Agreement is executed pursuant to the Purchase Agreement and may be executed in two counterparts, each of which as so executed shall be deemed to be an original but both of which together shall constitute one and the same instrument. A facsimile signature shall be acceptable as an original for all purposes.
- 4. <u>Binding Effect</u>. This Agreement shall inure to the benefit of and be binding upon Buyer and Seller, and their respective successors and assigns, but shall not create any right of subrogation or other right on the part of any other person.
- 5. <u>Amendment, Waiver or Termination</u>. This Agreement cannot be amended, waived or terminated except by a writing signed by the parties hereto.
