ITEM SUMMARY, JUSTIFICATION and/or SPECIAL CONSIDERATIONS:

ORDINANCE NO. 2013 - ____, An ordinance of the Pima County Board of Supervisors, establishing prima facie reasonable speed limits for motor vehicles on Camino Verde in Pima County, Arizona. Staff recommends **APPROVAL**. (District 3)

The reason for this ordinance is to provide consistency of the speed limits for the residential collector roadways within the Star Valley subdivisions which are adjacent to Wade Road and south of Valencia Road.

A traffic study initiated by a citizen's request revealed that the speed limit on Camino Verde between Los Reales Road and north of Brightwater Way was inconsistent with the newly posted speed limit on Wade Road. The resulting traffic study determined that the speed limit on this segment of Camino Verde under the existing operating and geometric conditions should be reduced from 45 miles per hour (mph) to 35 mph. This ordinance will reduce the speed limit for Camino Verde between Los Reales Road and 190 feet north of Brightwater Way to 35 mph. The speed limits for all other segments of Camino Verde will not change.

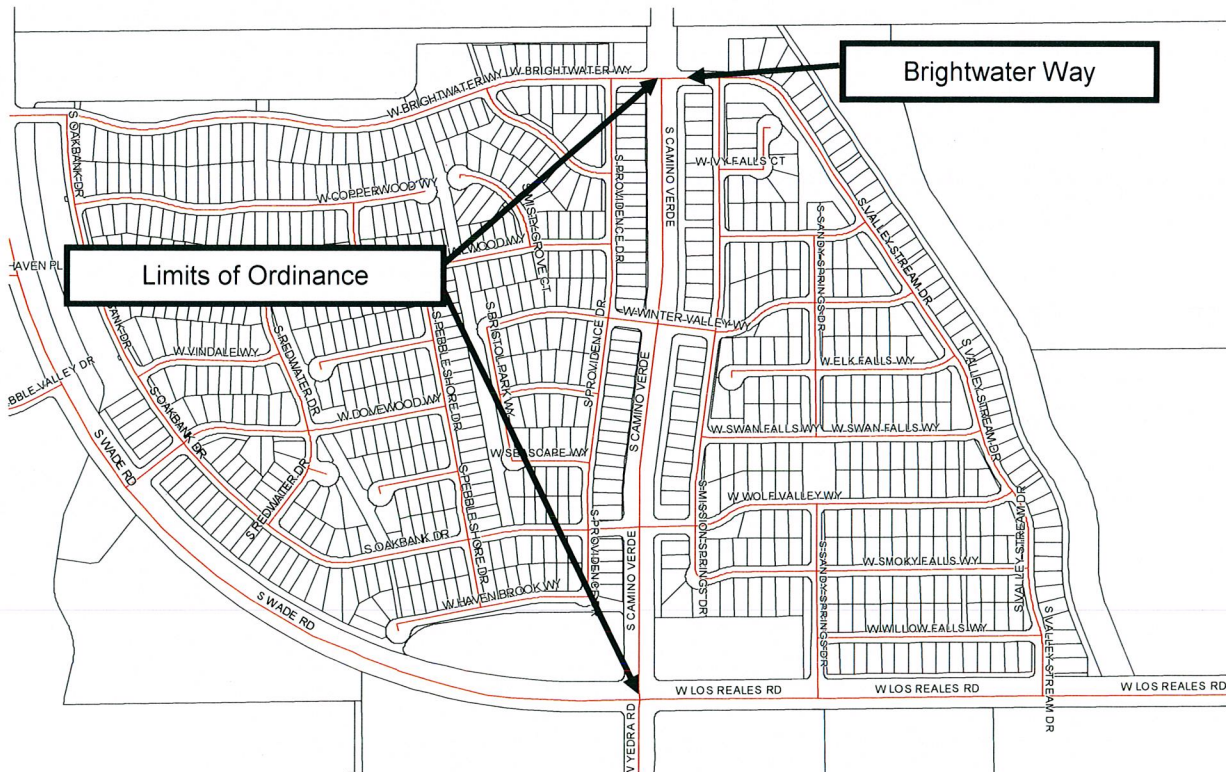

ORDINANCE NO. 2013-____

**AN ORDINANCE OF THE PIMA COUNTY BOARD OF
SUPERVISORS ESTABLISHING PRIMA FACIE
REASONABLE SPEED LIMITS FOR MOTOR VEHICLES
ON CAMINO VERDE IN PIMA COUNTY, ARIZONA**

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627, 28-701 and 28-703, as amended, to fix prima facie reasonable speed limits on through highways, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined the prima facie reasonable speed limits for motor vehicles on portions of Camino Verde,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. The reasonable and safe prima facie speed limit on Camino Verde be established as follows:

<u>SPEED LIMIT</u>	<u>FROM</u>	<u>TO</u>
a) 35 mph	Los Reales Road	190 feet north of Brightwater Way
b) 45 mph	Valencia Road	Nebraska Street
c) 35 mph	Nebraska Street	Bopp Road

SECTION 2. Ordinance 2006-104 is repealed and all other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take effect when and to the extent that signs are posted on the highways herein listed giving notice of the prima facie reasonable speed limits.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.


