

RE: **County-Wide Behavioral Health Crisis System Administration/Community Partnership of Southern Arizona (CPSA), Amendment 5, Request to Add Item to Board of Supervisor Addendum for Meeting March 10, 2015**

Behavioral Health seeks approval to place Amendment 5 to the CPSA/Pima County contract on the Board Addendum for Tuesday, March 10, 2015.

Amendment 5 is to an existing contract between Pima County and Community Partnership of Southern Arizona (CPSA) to administer and coordinate the provision and payment of civil commitment services required of Pima County and Arizona Revised Statutes Title 36-501 et seq.

This contract, which began on July 1, 2010, links the administration of the civil commitment services to the designated Regional Behavioral Health Authority (RBHA) contract the State of Arizona to coordinate mental health services in Pima County. The goals of this partnership are a greater cohesion in the continuum of care for this at-risk population, greater advocacy and intervention on the front end of the involuntary commitment process, and more individuals being offered alternative treatment venues other than an involuntary commitment setting.

A three-month extension is requested as Pima County Behavioral Health issued a Request for Proposal (RFP) on November 24, 2014, for these same services. Pima County is requesting a three (3) month extension so that whoever the successful Offeror is from the RFP can begin to provide services coterminous with the new Regional Behavioral Health Authority (RBHA), whose contract with the State begins on October 1, 2015.

A summary of the changes set forth in Amendment 5 are as follows:

- A three-month extension to Article 1 (Term and Extension) of the contract term, from June 30, 2015 to September 30, 2015.
- Article III (Payment) of the contract. As a result of the three-month extension the total contract amount has increased by \$1,230,586, from \$24,488,548 to an amount not to exceed \$25,719,134.
- Added language to the Contract Amendment (Article 1 – Term) regarding the survivability of some clauses after the expiration date of September 30, 2015, until the relevant dates of service have been completed. Most of the services described that are beyond the expiration date of the contract are final reconciliation reports due to the County from the Contractor prior to April 2016.
- Exhibit B Compensation 07/01/2013 - has been replaced in its entirety with an amended Exhibit B Compensation dated 07/01/2015. What changed in this exhibit are the reconciliation report dates, which have been pushed out accordingly as a result of the three-month extension. Additionally, Section 3 Budget has been updated to reflect the anticipated funds that will be
