

This email is written on behalf of AYSO Region 206 (Northwest Tucson) in response to the "Proposed Amendments to Natural Resources Parks and Recreation Fee Schedule".

The February 3, 2022 Memorandum to the Pima County Board of Supervisors from Jan Lester notes that NRPR will host publicized virtual open house sessions to receive input on the "Proposed Amendments to Natural Resources Parks and Recreation Fee Schedule." Would you please add our Regional Commissioner for AYSO 206, Mr. Zeno Pfau and myself (

the Assistant Regional Commissioner and Fields Coordinator for AYSO 206, to the list for the virtual open house sessions?

We are attaching an Excel spread sheet to show the impact to AYSO 206 on the proposed fee schedule versus our costs for our 2021 Fall Season. This analysis is based on the assumption that we will use the same number of hours of field time and light time for the 2022 Fall Season as we did in 2021 Fall Season.

The attached spreadsheet shows:

- 1. We have broken down the hours of field use for weekday practices and Saturday games with hours based upon the final Pima County 2021 field permits for the ten (10) fields under permit with AYSO 206.
- 2. We have also broken down the hours of light use based upon the 2021 MUSCO reports for the AYSO 206 Fall Season.

Our analysis shows that the proposed fee changes will double our current field use/light use budget from \$4,524 to \$9,764 or a 116 % increase. We understand the need to charge for field use to non-profits and for profit organizations. We would hope that this process would make it more financially feasible for Pima County to develop more recreational fields for the community in the future.

Additionally, would you please clarify when the proposed rates would take effect? We ask that you consider a phased field use fee such as \$ 2/hour in 2023 and another \$2/hour in 2024. If a fee increase is approved, please consider the rates taking affect at the second quarter of 2023. This

would allow leagues to adjust their budgets and player fees to take into account any fee increases.

Thank you in advance for your consideration of the above information in your decision on the proposed amendment to the Natural Resources Parks and Recreation fee schedule.

The \$75,000 On behalf of the FC Tucson Youth soccer club, the largest youth soccer club in Southern Arizona and largest user of Pima County sports fields, we oppose the County's proposed user fee.

We already pay the County \$75,000 a year for lights so we can actually use the parks after school, is one of our largest expenses, an expense paid from fees collected from our families.

We are a nonprofit and not a penny of the money we raise is spent that doesn't bring value to the programs we provide for thousands of Pima County kids. We run a tournament that is second only to the Shootout and brings in thousands of out-of-town guests, boosting the Pima County economy.

Additionally, FCTY spends \$100,000 a year in need-based financial aid/scholarships to documented low-income families who could not play without this assistance. No Pima County child is turned away from our program for financial reasons. The \$35,000 a year user fee that NRPR wants to assess against us easily represents the financial assistance we provide to at least 25 families.

I think that we are basically dealing with a philosophical difference of opinion between NRPR and most all of its constituents. As you point out, taxpayers bear the largest burden on the electrical costs. As they should. The users of Pima County parks are all taxpayers and expect that one of the reasons they pay taxes is so they can have properly maintained parks and fields where they can recreate. When we go to a park, we don't expect to pay another "tax" in the way of user fees or even light fees for that matter. We pay taxes so we can have these things Parks should not be profit centers for the County.

Beyond that phi osophical difference, NRPR could not have possibly picked a worse time to make this proposal. We have an obesity epiclemic among the youth in Pima County, I can send you the statistics. This is a bad situation getting worse due to the pandemic and the failure of thousands of kids to re-engage with their sports and outdoor recreation teams. While virtually all youth sports have been back in action for a year or more and restrictions have been lifted, a huge number of kids remain on the couch.

Len forwarded me your email to provide a response.

The public comment period is open for 60 days. We would like comments no later than April 30, 2022. Once the comment period is over we will have two virtual meetings for those that want to voice their support or opposition to the proposed fees. We haven't announced the dates of the two virtual meetings but they should occur in May and June 2022 timeframe. The NRPR department puts forth the recommendation to the Pima County Natural Resources Advisory Commission (NRPRAC) for review/approval. The proposed fee schedule was on the December 10, 2021 NRPRAC agenda. This was discussed at the meeting and unanimously approved. I did notice you did not attend the December 10, 2021 however the agenda was sent out prior to the meeting and no comments were received by you. Nevertheless, we have decided to reach out to the public for comments/suggestions on our proposed fee schedule amendments. We will review all public feedback and if necessary we will adjust our proposed fee adjustments accordingly. I plan on going back to the NRPRAC with results of our public outreach efforts at the July 8, 2022 meeting and if modifications have been made to the fee schedule will request approval of the revised fee schedule.

The primary purpose of the fee field use fee is field optimization. As you are aware we have two league representative meetings per year where field allocation is requested by the various leagues. We assign field allocation based on league size/enroment numbers. We have heard on numerous occasions from other league representatives that X league is not using their allocated field space. This is also evident when we do unannounced field audits and fields sit empty when per the field allocation should be in use. By enacting a modest fee it will empower leagues to surrender field use they are not utilizing making it available to other users. We have more field use requests than we have availability. We are constantly turning away youth softball, club baseball, lacrosse, rugby, flag football, etc. requests due to lack of available fields. This modest fee will benefit organizations or individual teams looking for additional field space. I also want to share that for the past several months I have been speaking with the City of Tucson Parks and Recreation regarding our intent to

impose a field use fee. They agreed and already had plans to go before Mayor and Council this spring with a similar field use fee proposal. We want to ensure that the two largest municipalities have similar fees for field use so as not to compete with each other.

The second reason is cost recovery. As you are aware we currently receive zero fees for field use by our youth organizations. The ball fields are living breathing assets. Our average cost to maintain one ball field is approximately \$36,304.13. The cost per field includes labor, water, fertilizer, pesticide, soil amendments, sod, top dressing, irrigation repairs, aeration, dragging, mowing, edging, painting lines, etc. Over the past several years we have spent quite a bit of time focusing on the quality and health of the playing surface. For those multi-use fields used by our soccer leagues it has been necessary to buy sod to install in high use areas. In 2018, your organization was generous to donate funds to install sod at Brandi Fenton and Rillito. The field use fee will help offset a portion of the maintenance costs. For the dad that wants to go out on Sunday morning and toss the ball with his son, there is no fee as this incidental use is covered by the property taxes he pays. However, for leagues that utilize the ball fields every day is more than incidental use and as primary users should pay a nominal fee to offset maintenance.

As a taxpayer, I feel that we pay plenty in city and county taxes for our children to be allowed to play on fields that are, keep in mind, not over seeded in the winter time.

As a parent and practicing pediatric cardiologist, however, I am even more concerned about the negative impact this decision will have on the health of youth in Tucson by impeding access for children of families that were already struggling to afford for the son or daughter to participate in youth sports. In a time when the physical and mental health of our youth has been so profoundly impacted by the Covid 19 pandemic, I feel that this is a detrimental and poorly considered move by the county. On behalf of FC Tucson Youth, the largest youth soccer club and principal user of Pima County Park sports fields we wish to voice our opposition to any user fees being added to the \$75,000 a year we already pay for lights so we can actually use the parks after school, which is one of our largest expenses, an expense paid from fees collected from our families.

We are a nonprofit and not a penny we raise is spent that doesn't bring value to the programs we provide for thousands of Pima County kids. We run a tournament that is second only to the Shootout and brings in thousands of out-of-town guests, boosting the Pima County economy.

Additionally, FCTY spends \$100,000 a year in need-based financial aid/scholarships to documented low-income families who could not play without this assistance. No Pima County child is turned away from our program for financial reasons. The \$35,000 a year user fee that NRPR wants to assess against us easily represents the financial assistance we provide to at least 25 families.

I think that we are basically dealing with a philosophical difference of opinion between NRPR and most all of its constituents. As you point out, taxpayers bear the largest burden on the electrical costs. As they should. The users of Pima County parks are all taxpayers and expect that one of the reasons they pay taxes is so they can have properly maintained parks and fields where they can recreate. When we go to a park, we don't expect to pay another "tax" in the way of user fees or even light fees for that matter. We pay taxes so we can have these things. Parks should not be profit centers for the County.

Beyond that philosophical difference, NRPR could not have possibly picked a worse time to make this proposal. We have an obesity epidemic among the youth in Pima County. I can send you the statistics. This is a bad situation getting worse due to the pandemic and the failure of thousands of kids to re-engage with their sports and outdoor recreation teams. While virtually all youth sports have been back in action for a year or more and restrictions have been lifted, a huge number of kids remain on the couch.

One of the principal missions of NRPR ought to be to address issues like this in a way that promotes outdoor activities for our children. Assessing new costs to parents will have quite

the opposite effect—even fewer kids will play. We are likely on the brink of an economic crisis that w'll most certainly have the greatest impact on low-income families. The war in Ukraine and 'ts consequences are going to stretch the pocketbook for Morn and Dad even further.

Additionally, a modification in NRPR's field reservation system could alleviate concerns about unused reserved fields without the need for additional fees. Maybe try carrots and not sticks.

I would also suggest we should not ignore the elephant in the room. Pima County has a tenant running a gambling and a cohol sales business on roughly 70 percent of the real estate at Rillito Park. I would suggest NRPR ought to be proposing this user fee be assessed against that tenant, or at least 70 percent of it.

Finally, think the best way to address issues like these is to bring all stakeholders together to brainstorm so we can avoid creating financial hardships for Pima County families. Hook forward to continuing this constructive dialogue so that we can arrive at a solution that best meets the needs of our community, especially its most important stakeholders: Our children.

I have lived out in Three Points majority of my life. As a small girl, I was the type that was given a free or reduced lunch because as a single family out here not making enough money times were tough. Now, I'm a single mother of four children, also, on reduced/free lunches.

It's been brought to my attention about the possibility of NRPR fees for the after school program here at Robles Ranch. Back in 2004, "Tucson Weekly" published how Three Points was doomed with 80% of the students out here on a free/reduced lunch BECAUSE THE FAMILIES OUT HERE LIVE BELOW THE POVERTY LINE. We are struggling enough here in the desert without the help of Pima County officials in granting grants for our children to play safely at Robles Ranch. I remember when Ms. Whitfield started up with the help of NRPR, the after school program, with my own daughter attending at the age of 4, whose now 13 and her younger siblings attend the after school program now (or will be shortly in the next few years with a slight age difference of a year between the younger siblings ages 6,4, and 3).

Between COVID closures of the schools out here that put the parents who are tirelessly working to support their small families and the possibilities of having fees attached to our after school program it becomes more stressful. I don't receive child support for my three younger ones, I work two jobs and I'm in college and I even have a hard time making ends meet on occasion. To add another "bill" two times a year will be hard on me, as I'm already struggling enough currently.

I understand that there's no such thing as a free lunch but our children don't have anything to do out here, it's not like we have the YMCA to go to, or a library either or even an after school program for the younger children (ages say from 5-8) to do. Robles Ranch is supposed to be a place to gather and meet, community services when not in session for holidays or when our children want to play there rather than at the park next to the fire station off Sasabe Road across from the school.



I reviewed the proposed fee increase for the S.E. Regional Park & Tucson Mountain Park shooting ranges. Both shooting ranges are overwhelmed with users and are in dire need of expansion, not only in capacity but in distances able to shoot. This must be done in order to justify price increases on facilities that at times cannot even be used satisfactorily.

In 2021, I tried visiting the TMP range with my daughters for safety training. I drove a long distance to the range. When I arrived, the parking lot was full and the range officer said there was a long waiting list (estimated 2hr plus) of even hoping to use the range. We decided to leave and drove into the desert to shoot. It turns out the Pima County desert was completely littered with trash and remnant shells from people. Some of which were possibly "turned away" from the range as we were.

In 2021/2022, I visited the SERP range many times. (about 20-25 times). The range is often at 90+ percent capacity. People waiting on benches to enjoy what they paid for is a common sight.

Both ranges are extremely limited in the distances able to shoot. TMP is 100 yards and SERP is 200 yards. These were sufficient distances in the 1920s-1970s. However, today's average commonplace optics and firearms are far more capable than 50 to 100 years ago. If a price increase were to be adopted, then it must be accompanied by both capacity & capability expansions.
