Title: Camino Verde Through Street

Introduction/Background:

The reason for this ordinance is to establish Camino Verde as a through street between Los Reales Road/Wade Road and Valencia Road to allow for installation of effective traffic control.

Discussion:

Camino Verde from Los Reales Road/Wade Road to Valencia Road is a north/south two lane road that serves the Star Valley subdivision. A review of the local roads that intersect with Camino Verde determined the need to establish an ordinance for effective traffic control at all side streets.

Conclusion:

Camino Verde is recommended to be established as a through street.

Recommendation:

Pima County Traffic Engineering recommends Camino Verde be established as a through street from Los Reales Road to the south line of Brightwater Way and from the north line of Brightwater Way to the south line of Valencia Road. The breaks in through street designation are due to traffic control installed at the intersections of Brightwater Way and Valencia Road.

ORDINANCE NO. 2016- ____

AN ORDINANCE OF THE PIMA COUNTY BOARD OF SUPERVISORS ESTABLISHING CAMINO VERDE AS A THROUGH STREET IN PIMA COUNTY, ARIZONA

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-855 as amended, to designate through streets and erect stop or yield signs, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined that it is necessary for the protection and convenience of the traveling public of Pima County, Arizona, to designate Camino Verde as a through street,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. Camino Verde be designated a through street as follows:

<u>FROM</u>	<u>TO</u>
a) Los Reales Road	The south line of Brightwater Way
b) The north line of Brightwater Way	The south line of Valencia Road

SECTION 2. All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take effect when and to the extent that stop or yield signs are posted on the intersecting streets.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
