EXECUTIVE SESSION

4. Pursuant to A.R.S. §38-431.03(A) (3) and (4), for legal advice and direction regarding a proposed settlement in Pima County Flood Control District v. Fidelity National Title Agency, et al., Pima County Superior Court Case No. C20132297.

Chris Straub, Chief Deputy County Attorney, reported that the Pima County Flood Control District sought to condemn approximately 85.63 acres of property in and along the Cañada del Oro floodway. On October 22, 2013, both parties participated in a settlement conference at which a proposed settlement was reached. Under the proposed settlement the Pima County Flood Control District would pay a total of \$1,000,000.00 in just compensation for the 85.63 acres, plus an additional 69.72 acres of property along the Santa Cruz River between Valencia and Irvington Roads. As a part of the proposed settlement, the County Administrator and the County Attorney's Office recommended that the Board exercise its authority of

eminent domain to acquire Tax Parcel Nos. 137-11-431D, 137-11-431G, 137-11-431J, 137-33-5710 and 137-33-5810 for flood control purposes and authorize the Pima County Attorney to amend the complaint to condemn those additional parcels.

It was moved by Supervisor Bronson, seconded by Supervisor Elías and unanimously carried by a 5-0 vote, to accept the recommendation.

5. **Riparian Habitat Mitigation**

Staff requests approval of a Riparian Habitat Mitigation Plan for property located at 4001 N. Soldier Trail, within an important riparian area with underlying Class H Habitat. (District 4)

Supervisor Bronson stated that the language needed to be broadened with the intent of focusing on the wildlife linkages in the long term.

Chuck Huckelberry, County Administrator, proposed striking the phrase "with an emphasis on" and inserting the word "including" in Section 4.2.5 of the Agreement.

It was moved by Supervisor Bronson, seconded by Supervisor Miller and unanimously carried by a 5-0 vote, to adopt the Resolution, approve the Amendment to the Development Agreement with the language suggested by the County Administrator, and to direct staff to continue to evaluate alternative routes to facilitate wildlife movement and achieve the goal of trail connectivity, and to continue to work with the Oversight Committee.

The Hearing Administrator recommends APPROVAL SUBJECT TO STANDARD AND SPECIAL CONDITIONS. (District 3)

Standard Conditions & Requirements per the Pima County Zoning Code

The Pima County Zoning Code stipulates no standard requirements for this use. See the proposed Special Conditions recommended below.

Special Conditions Recommended by the Hearing Administrator

- 1. This conditional use permit approval is for an equipment testing facility and its related operations and activities only; no other commercial/industrial use is granted.
- 2. This conditional user permit applies only to the 658-acre lease area as delineated in the applicant's submittal materials. Any expansion of the facility beyond the 658-acre site shall require a new conditional use permit application, public notice, public hearing, etc.
- 3. The use shall proceed in substantial conformance with the site plan as submitted in the applicant's submittal materials.
- 4. The facility operations and attendant field testing shall occur primarily on weekdays and primarily between 6:00 AM and 7:00 PM. It is understood that some activity may be required slightly after 7:00 PM on some weekdays and that some testing may need to take place on the weekend, but it is the Hearing Administrator's expectation that these will be occasional events only and not become the prevailing norm. On-going or regular weeknight activity after 7:00 PM and/or on weekends will be considered a violation of this special condition.
- 5. All assembly and maintenance of equipment shall occur indoors within the "proposed truck shop facility" building as shown on the submitted site plan. Assembly and maintenance of equipment shall occur indoors within the "proposed truck shop facility" building as shown on the submitted site plan. It is understood that limited, minor activity may need to occur on adjacent building aprons from time to time. Such minor and infrequent activity on the aprons is acceptable as long as it remains both minor and infrequent.
- 6. No blasting shall occur on the lease property.
- 7. No actual mining or materials processing activity shall occur on the lease property, only the loading, unloading, maneuvering, etc. as described at public hearing.
- 8.
