RE: Adoption of RESOLUTION NO. 2025 - FC1 on the 2025 Floodplain Management Plan

Dear Chair Scott and Members of the Board,

The Coalition for Sonoran Desert Protection supports the adoption of RESOLUTION NO. 2025 - FC1 by the Flood Control District Board of Directors.

We were actively involved in the Pima County Regional Flood Control District's (PCRFCD) stakeholder Planning Committee for the 2025 Floodplain Management Plan (Plan), where we represented environmental interests. We commend PCRFCD for the success of this Planning Committee, which facilitated valuable collaboration with diverse stakeholders and allowed us to provide input on projects. We also gained a deeper understanding of the Floodplain Management Plan and its Watershed Master Plan.

We are especially pleased by the Plan's inclusion of a project we recommended, which will build on the momentum of the Santa Cruz River Wildlife Ramp — currently under construction, and the first of its kind in southern Arizona. Under this Plan, a working group will be formed to explore future ramp options and further connect our region's open spaces.

This is just one of many examples of cooperation in the Plan and its projects, which we feel is one of the Plan's strengths. We also commend the Plan's watershed-based approach, a proven best practice in landscape and water conservation, as well as invasive species management.

Finally, this Plan's ongoing commitment to the region's important riparian areas — through acquisition and management — remains central to our mission of protecting the Sonoran Desert in southern Arizona for generations to come. Beyond the numerous benefits we all receive from healthy riparian ecosystems, this investment in naturally functioning



floodplains enables Pima County to maximize flood insurance discounts and federal funding benefits through FEMA's Community Rating System or CRS.

We thank you for your adoption of this resolution approving the Plan.
