**AMENDMENT NO. 2 TO THE  
INTERGOVERNMENTAL AGREEMENT FOR THE PROVISION AND  
ADMINISTRATION OF CHILDHOOD IMMUNIZATIONS BETWEEN  
SAHUARITA UNIFIED SCHOOL DISTRICT NO. 30 AND PIMA COUNTY  
CONTRACT NO. CTN 12\*0094**

THIS AMENDMENT to that certain Intergovernmental Agreement by and between Pima County, a body politic and corporate of the State of Arizona, for and on behalf of the Pima County Health Department, hereinafter referred to as the "COUNTY", and Sahuarita Unified School District No. 30, a political subdivision of the State of Arizona, hereinafter referred to as "DISTRICT".

WHEREAS, the COUNTY and the DISTRICT have entered into an Intergovernmental Agreement in a joint effort to provide required childhood immunization services to the school children of Pima County at no charge; and

WHEREAS, the Intergovernmental Agreement contains a specific provision allowing the Parties to extend the Agreement for up to four additional one-year periods;

NOW, THEREFORE, the following Amendment is agreed upon as follows:

- I. Article I. TERM – The Parties to this Intergovernmental Agreement exercise the option to extend the Agreement for a period of one (1) year, beginning July 1, 2013 and ending June 30, 2014.
- II. The effective date of this Amendment is June 30, 2013.

All other provisions of the Intergovernmental Agreement, not specifically revised by this Amendment, remain unchanged.


