***Title:**

Vote Center and Board Worker Appointments for the November 7, 2023 Vail Incorporation Election

***Introduction/Background:**

Arizona Revised Statutes §16-411 requires the Board of Supervisors, in advance of Election Day, to designate polling places or vote centers for use on Election Day. Additionally, the Board is required to appoint election board workers for each vote center as prescribed in A.R.S. §16-531.

***Discussion:**

The Board is being asked to designate three vote center locations for the Vail Incorporation election to be held on the consolidated election date of November 7, 2023. The Vail Incorporation is not part of the all ballot by mail consolidated elections, therefore, the designation of vote centers is required to allow eligible voters the opportunity to cast their ballot in person on Election Day. Vote center locations will be included in the sample ballots mailed to voter households in advance of Election Day.

The Elections Department has recruited election board workers for the three vote center locations on Election Day. Each board maintains equitable representation from Pima County's two major political parties.

***Conclusion:**

The Board is being asked to approve the list of vote center locations and board workers that will be used for the Vail Incorporation election. By approving the lists the Board of Supervisors will be in compliance with A.R.S. §16-411 and A.R.S. §16-531.

***Recommendation:**

The Elections Department recommends the approval of vote center locations and board workers for the November 7, 2023 Vail Incorporation Election as proposed.

***Fiscal Impact:**

Each facility is charging for use of the space at \$500 each, totaling \$1,500 for all three locations.
