*Purpose:

Amendment of Award: Master Agreement No. MA-PO-21-171, Amendment No. 04. This Amendment exercises the annual renewal option to extend the termination date to 04/11/2023 and increases the shared not-to-exceed contract amount by \$500,000.00 for a cumulative not-to-exceed contract amount of \$1,050,000.00. One (1) six-month renewal option remains. Administering Department: Fleet Services.

*Procurement Method:

Pursuant to Pima County Procurement Code 11.12.060, Emergency and other limited competition procurement, on 04/12/2021, the Procurement Director approved an award of contract for an initial term of six (6) months and a shared not-to-exceed contract amount of \$250,000.00 (including sales tax) with four (4) six-month renewal options.

Effective 10/12/2021, the Procurement Officer processed Amendment No. 01, which extended the termination date to 04/11/2022. No additional funding was added and the shared not-to-exceed contract amount remained at \$250,000.00. Three (3) six-month renewal options remained.

On 12/21/2021, the Board of Supervisors approved Amendment No. 02, which extended the termination date to 10/11/2022 and added the shared amount of \$300,000.00 for a cumulative not-to-exceed contract amount of \$550,000.00. Two (2) six-month renewal options remained.

On 07/28/2022, the Procurement Director approved Amendment No. 3, which expanded the scope for Diamond Transportation Arizona, LLC dba Diamond Transportation and Mountain View Tours, Inc. to include interstate travel.
