Re: Additional Information for the November 7, 2023 Board of Supervisors Meeting – Agenda Items #25 & #26, H-1B One Workforce Program Subrecipient Agreement

Amendments

On February 2, 2021, the Board of Supervisors accepted an award of the H-1B One Workforce Grant in the amount of \$4 million to develop replicable, comprehensive workforce strategies for preparing the workforce for middle-to-high skilled occupations within the information technology, advanced manufacturing, and transportation sectors. The H-1B One Workforce Grant Program is authorized by the American Competitiveness and Workforce Improvement Act through the grantor agency U.S. Department of Labor Employment and Training Administration.

Although Pima County is the Grantee, it is designed to promote activities throughout Southern Arizona. In order to effectuate the grant in Santa Cruz and Cochise Counties, Pima County subawarded \$587,312.00 to Santa Cruz County (CT-CR-21-361, approved June 22, 2021) and \$1,493,426.19 to Cochise Private Industry Council, Inc. dba ARIZONA@WORK Southeastern Arizona (CT-CR-21-356, approved April 20, 2021). Santa Cruz and Cochise Counties fall within the boundaries of the Innovation Frontier Arizona Congressional Districts (AZ-001, AZ-002, AZ-003).

As Grantee, Pima County is responsible for these agreements. Santa Cruz and Cochise Counties are responsible for budgets that contain specific programmatic performance metrics such as for training and supportive services in their respective contracts. Goodwill Industries of Southern Arizona, another subrecipient, is responsible for successfully addressing performance metrics to provide designated personnel for outreach purposes to market and obtain participants for the H-1B Grant Program.

Due to a variety of factors, including the challenging hiring market and altered economic landscape that have followed the pandemic, discussions began earlier this year about revising the subrecipient agreements with Santa Cruz County and Cochise Private Industry Council to reflect the revised participant goals and corresponding budgets for those subrecipients. Additionally, Pima County has capacity to serve additional participants, ensuring overall grant metrics are satisfied. The amendments now being presented for approval reflect the product of those negotiations. The original and revised participant numbers are reflected in the attachment.
