WHEREAS, pursuant to A.R.S. § 8-231, the Presiding Juvenile Court Judge has the authority to appoint Juvenile Court Commissioners, and

WHEREAS Kristin J. Schrinier meets the qualifications for appointment as a Superior Court Commissioner pursuant to A.R.S. § 12-213 and the qualifications for appointment as a Juvenile Court Commissioner pursuant to A.R.S. § 8-231,

IT IS THEREFORE ORDERED appointing Kristin J. Schrinier as a full-time Pima County Superior Court Commissioner and a full-time Juvenile Court Commissioner to serve at the pleasure of the Presiding Judges of Pima County Superior Court and Pima County Juvenile Court, effective July 11, 2022. Commissioner Schrinier's initial service on either the Superior Court or the Juvenile Court to be at the discretion of the Presiding Judge of the Superior Court and the Presiding Judge of the Juvenile Court.
