RE: Official Notice of Nomination of Three Qualified Electors to be Considered for Legislative District 20 House Vacancy

Hello Ms. Manriquez-

In accordance with A.R.S. § 41-1202: On Saturday, July 8th, 2023 (10:00 AM) via ZOOM; Legislative District 20 gathered to "nominate three qualified electors to fill the vacancy who meet the requirements for service in the legislature, who belong to the same political party and who reside at the time of nomination in the same district and county as the person elected to or appointed to the office immediately before the vacancy."

The "vacancy," as defined in A.R.S. § 38-291(3), is in **Legislative District 20 for the seat formerly held by Andres Cano in the Arizona House of Representatives.**

Only Democratic elected precinct committeepersons of Legislative District 20 were eligible to vote to nominate the three qualified electors who met the criteria described above. All who met the criteria for nomination were eligible to submit their name and participate in this process. The meeting notification was sent via email to all the PCs and the email list in LD20. In addition, it was added to the LD20 website no fewer than 48 hours before the meeting took place. Press were provided the link and able to join the meeting, and at least one member of the press was present.

The three qualified electors to fill the vacancy by the nomination of elected committeepersons of Legislative District 20 are as follows in the order of alphabetical last names.
