ITEM SUMMARY, JUSTIFICATION and/or SPECIAL CONSIDERATIONS:

ORDINANCE NO. 2013 - ___, An ordinance of the Pima County Board of Supervisors, establishing Sunset Road as a through street in Pima County, Arizona. Staff recommends **APPROVAL**. (District 1, 3)

The reason for this ordinance is to establish Sunset Road as a through street and provide regulatory authorization of the existing stop and yield signs at the intermediate cross streets.

Due to changes in jurisdictional boundaries and developer-installed signing improvements, the existing through street ordinances are no longer valid as written. This ordinance will consolidate and redefine the through street ordinance limits for Sunset Road to properly address the existing intersection traffic control signs.

ORDINANCE NO. 2013- ____

**AN ORDINANCE OF THE PIMA COUNTY BOARD OF
SUPERVISORS ESTABLISHING SUNSET ROAD AS A
THROUGH STREET IN PIMA COUNTY, ARIZONA**

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-855 as amended, to designate through streets and erect stop or yield signs, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined that it is necessary for the protection and convenience of the traveling public of Pima County, Arizona, to designate Sunset Road as a through street,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. Sunset Road be designated a through street as follows:

<u>FROM</u>	<u>TO</u>
a) The east line of Anway Road	The west line of Antelope Road
b) 1.0 mile west of Vereda del Coyotito	1308 feet west of Camino de Oeste (Town of Marana Limits)
c) The east line of Kain Avenue	The west line of La Cholla Boulevard
d) The east line of La Cholla Boulevard	Oracle Jaynes Station Road
e) The east line of Cheyenne Avenue	The west line of La Canada Drive

SECTION 2. Ordinance 1969-050 Section 1 Part 91, Ordinance 1980-119 Section 1 Sunset Road, and Ordinance 1982-139 Section 1 Sunset Road are repealed and all other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflict.

SECTION 3. This ordinance shall take effect when and to the extent that stop or yield signs are posted on the intersecting streets.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
