**CONTRACT AMENDMENT**

The parties agree to amend the above-referenced contract as follows:

**1. Background and Purpose.**

1.1. Background. On May 5, 2020, County and Contractor entered into the above referenced agreement to allow operation and maintenance of Centro Del Sur Community Center and Boxing Gym.

1.2. Purpose. Contractor is using the Premises solely for the purpose of operating, administering and coordinating the training of youth and adult-based amateur and professional boxing programs, martial arts, and weight and physical training. The purpose of this amendment is to extend the contract for one additional year.

**2. Term.** The County is exercising the fourth extension option to renew the contract for one additional year commencing on May 5, 2024 and terminating on May 4, 2025. If the commencement date is before the Effective Date of this amendment, the parties will, for all purposes, deem the amendment to have been in effect as of the commencement date.

All other provisions of the Contract not specifically changed by this Amendment remain in effect and are binding upon the parties.


