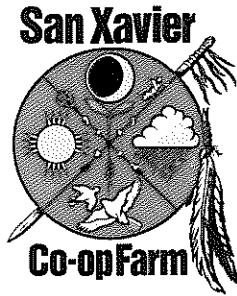

Dear Pima County Board of Supervisors,

The San Xavier Cooperative Association (SXCA) operates a farm on the San Xavier Indian Reservation, which is located in Pima County, Arizona. We are a 1500 acre farm that produces traditional O'odham crops, produce, and alfalfa, and engages in beekeeping for honey production, wild food harvests, and other value-added products. The SXCA Farm is committed to sustainable farming practices that support economic development and health in the community and farms by avoiding the use of herbicides and pesticides. The Farm participates in the Tucson food network, and collaborates with local entities, as the Community Food Bank, Native Seed/SEARCH, local farmers' markets, University of Arizona Compost Cats, and other local growers.

The Farm is also aware that the Tucson community supports and purchases locally grown non-GMO produce and food crops. The greater public is becoming aware that consuming genetically modified organisms (GMOs) seed crops are unhealthy and may be the possible cause of diseases, now prevalent in the larger society.

Monsanto has purchased land in Marana for the purpose of growing GMO corn seeds, and will use pesticides and herbicides in this effort, and Monsanto's operation will produce negative effects on local farm areas, and cause unwanted cross-pollution for food crops grown in Pima County. Monsanto does not have a good record of protecting the health of communities in which they operate, and we stand with those opposed to the Monsanto growing GMO seeds in Pima County.

San Xavier Cooperative Board hereby requests the Pima County Board of Supervisors to reject Monsanto's request for tax breaks, and ask that the Board support businesses that benefit the health, well-being and economy of the people in the County.
