Title: Resolution No. 2021 providing for the vacation and abandonment of "Old" State Route 83. File A-0054			
Introduction/Background:			
The abandonment applicant has requested an abandonment of a portion of the "Old" State Route 83. The roadway is a public roadway lying within Section 1, Township 18, Range 16 G&SRM, Pima County, Arizona, as shown on attached Location Map.			
Discussion:			
The subject roadway was abandoned by Resolution # 75-20-A-78 to Pima County in 1975 by Arizona Department of Transportation as a result of completion of a new Highway alignment which bypassed the old roadway. The Resolution was recorded in Book 5156 at Page 105 on November 21, 1975. This roadway is not needed for public use and the applicant is requesting the abandonment to assemble with their adjacent parcels.			
Conclusion:			
This abandonment has been reviewed and approved by appropriate County staff and applicable utility companies and no properties will be left without public or private legal access. County has determined that the subject roadway is not needed for public use and shall be vacated upon conveyance to the applicant.			
Recommendation:			
Staff recommends that the Pima County Board of Directors approve Resolution No. 2021			
Fiscal Impact: Pima County will be removed from liability and have no maintenance responsibilities toward the subject roadway.

RESOLUTION OF THE PIMA COUNTY BOARD OF SUPERVISORS FOR THE VACATION OF A PORTION OF "OLD" STATE ROUTE 83, A PUBLIC ROADWAY, AS PIMA COUNTY ROAD ABANDONMENT NO. A-0054 WITHIN SECTION 1, TOWNSHIP 18 SOUTH, RANGE 16 EAST, G&SRM, PIMA COUNTY, ARIZONA

The Board of Supervisors of Pima County, Arizona finds:

- 1. An application has been received by Pima County for the vacation of a portion of "Old" State Route 83, a public roadway, abandoned to Pima County per recorded document in Book 5156 at Page 105 by the Arizona Department of Transportation on November 21, 1975, said roadway being more particularly described and depicted in attached **Exhibit "A" and "B"** (the "Roadway").
- 2. The Roadway was abandoned to Pima County as it was no longer needed due to new alignment of State Route 83 (Aka: Sonoita Highway) bypassing "Old" State Route 83. This roadway is not needed pursuant to A.R.S. §§ 28-7202 and 28-7215(B).
- 3. The Roadway may be disposed of by vacation to the Grantee pursuant to A.R.S. § 28-7205 and A.R.S. § 28-7215(B).
- 4. No land adjoining said roadway would be left without access to a public highway.

NOW, THEREFORE, BE IT RESOLVED,

The public roadway described and depicted in **Exhibit "A" and "B"** will be disposed of by vacation by Quit Claim Deed to Grantee, without compensation, in accordance with A.R.S. § 28-7205 and A.R.S. § 28-7215(B), reserving any and all rights-of-way or easements for drainage and utilities, which shall continue as they existed prior to and after this conveyance.

Upon recordation of the Quit Claim Deed, the subject roadway shall be deemed to be vacated and title shall vest in the Grantee.

EXHIBIT A LEGAL DESCRIPTION

A portion of the northwest one-quarter of Section 1, Township 18 South, Range 16 East, Gila and Salt River Meridian, Pima County, Arizona, said portion is a part that particular parcel as described in the Warranty Deed filed in Sequence number 20203430747, Records of the Pima County Recorder, said portion more particularly described as follows:

Said portion is a segment of the "Old" State Route 83 as described in Resolution 75-20-A-78, dated November 21, 1975 and filed in Book 5156 of Dockets, pages 105-114, Records of the Pima County Recorder, said portion more particularly described as follows:

COMMENCING at the southwest corner of said parcel as described in the Warranty Deed filed in Sequence number 20203430747 which is demarcated with a number 4 rebar affixed with a 1.5-inch diameter aluminum cap marked LS 13019;

THENCE upon the south line of said parcel, N 89°25'22" E, a distance of 48.77 feet to the **POINT OF BEGINNING**, from which a number 5 rebar affixed with a tag marked LS 4785, and demarcating the southeast corner of said parcel bears N 89°25'22" E, a distance of 515.66 feet;

THENCE leaving said south line, upon the westerly line of the herein described portion, N 35°37'27" E, a distance of 229.13 feet to a point on the arc of a curve;

THENCE continue upon said westerly line, upon the arc of said curve, to the left, an arc length of 521.64 feet, a radius of 2258.83 feet, a central angle of 13°13'53";

THENCE continue upon said westerly line, N 22°23'34" E, a distance of 313.27 feet to a point on the east line of the aforesaid parcel as described in the Warranty Deed filed in Sequence number 20203430747, from which a number 5 rebar affixed with a tag marked LS 4785 and demarcating the northeast corner thereof bears N 00°38'46" W, a distance of 464.07 feet;

THENCE upon said east line, S 00°38'46" E, a distance of 168.64 feet to a point, from which the aforesaid southeast corner thereof bears S 00°38'46" E, a distance of 757.30 feet;

THENCE leaving said east line, upon the easterly line of the herein described portion, S 22°23'34" W, a distance of 158.08 feet to a point on the arc of a curve;


THENCE continue upon said easterly line, upon the arc of said curve, to the right, an arc length of 536.88 feet, a radius of 2324.83 feet, a central angle of 13°13'53";

THENCE continue upon said easterly line, S 35°37'27" W, a distance of 180.82 feet to a point on the south line of the aforesaid parcel as described in the Warranty Deed filed in Sequence number 20203430747;

THENCE upon said south line, S 89°25'22" W, a distance of 81.79 feet to the **POINT OF BEGINNING**.

The herein described portion is a 66-foot-wide strip of land and has an area of 64,014 square feet, more or less.




