Title: Temporary Road Closure Resolution

Introduction/Background:

Country Fair White Elephant, Inc. has requested the temporary closure of portions of La Canada Drive from Camino Casa Verde/Camino Del Chino to Continental Road for the Country Fair White Elephant Parade on Sunday, October 30, 2016 from 10:00 A.M. to 12:00 P.M.

Discussion:

As a result of the Pima County Traffic Engineering Division's traffic control plan review, road closures, including a potential detour route if needed due to inclement weather or other circumstances, are recommended to facilitate the event.

Conclusion:

Pima County Traffic Engineering recommends the temporary closure of portions of La Canada Drive from Camino Casa Verde/Camino Del Chino to Continental Road to enhance the safety of the Country Fair White Elephant Parade event by reducing potential vehicular conflicts.

Recommendation:

Staff recommends approval of this resolution to temporarily close portions of La Canada Drive from Camino Casa Verde/Camino Del Chino to Continental Road for the Country Fair White Elephant Parade on October 30, 2016 from 10:00 A.M. to 12:00 P.M.
