*Project Title/Description:

State Grants-In-Aid (SGIA) 2024 for Pima County

*Purpose:

The State Grants-In-Aid funding for Pima County Public Library (PCPL) will support community engagement and learning opportunities aligned with our Community Impact Plan. This year, PCPL's focus is on revitalizing key relationships and improving communication and staff involvement during the Tucson Festival of Books (TFOB).

*Procurement Method:

Not applicable to grant awards.

*Program Goals/Predicted Outcomes:

The Library will enhance stakeholder relationships, team support, and infrastructure to achieve greater collaboration, participation, and effectiveness as it participates at TFOB in 2024.

*Public Benefit:

Pima County residents will experience significant educational and economic advantages by gaining access to a highly involved library that actively responds to community needs and opportunities.

*Metrics Available to Measure Performance:

PCPL will utilize indicator tracking to assess its community reach and staff satisfaction during the planning process, incorporating an after-action review approach.

*Retroactive:

Yes. The Arizona State Library sends award notifications in August, based on reporting from the previous year, with a period of performance that begins July 1. The Arizona State Library requires that PCPL submit the application once the award notice is received. If this award is not approved Pima County residents will have more limited access to resources, and diminished community engagement with PCPL.
