**A RESOLUTION OF THE PIMA COUNTY BOARD OF SUPERVISORS,
AUTHORIZING THE RENAMING OF THE CANOA PRESERVE PARK SOFTBALL
COMPLEX AS THE CHUCK CATINO SOFTBALL COMPLEX**

WHEREAS, Chuck Catino has been a dedicated advocate and instrumental in the planning and development of the Canoa Preserve Park; and

WHEREAS, Chuck Catino continuously and aggressively solicits funding sources for the continued development of the softball complex and the Canoa Preserve Park amenities; and

WHEREAS, Chuck Catino has raised cash donations, which are deposited through the Pima County Parklands Foundation, and in-kind contributions for the development of the park and the softball complex; and

WHEREAS, the Pima County Board of Supervisors finds that Chuck Catino is exceptionally worthy of recognition and wishes to name the Canoa Preserve Park softball complex as the *Chuck Catino Softball Complex* in his honor.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, AS FOLLOWS:

The *Canoa Preserve Park Softball Complex* is hereby renamed as the *Chuck Catino Softball Complex*, and the Pima County Natural Resources, Parks and Recreation Department is hereby authorized and directed to take the actions necessary to give effect to this resolution, including installation of new signage at the soft complex, updating maps and publications as appropriate, and advising the community and media of the renaming and the reasons for this action.
