2. Quit Claim Deed to: DCM Development Company, L.L.C., an Arizona limited liability company

Resolution and Quit Claim Deed executed by the Pima County Board of Supervisors pursuant to ARS 42-18302 and 42-18303, for the sale of the tax deed interest of the State of Arizona in tax parcel 111-03-0840. Said parcel being a portion of Lots 6, and 8 of Rillito Riverside Acres, as recorded in the office of the Pima County Recorder, in Book 5 of Maps and Plats at Page 46, in Section 28, Township 13 South, Range 14 East, Pima County, Arizona.

The property to be sold is a small strip of land in the City of Tucson and is surrounded by residential and commercial property. The property had been conveyed to the State of Arizona for delinquent property taxes in 1972 by instrument recorded in Docket 4186 page 408 in the Pima County Recorder's Office. DCM Development Company, L.L.C., an Arizona limited liability company was the highest bidder at the auction sale held on May 6, 2013. The sale price is \$500.00 plus a \$500.00 administrative fee, totaling \$1,000.00 to be paid in cash upon Board of Supervisor's approval, at which time the sale will be finalized and closed.

That the Pima County Treasurer is hereby directed to strike from the tax rolls all outstanding taxes now due and owing on the subject property.


