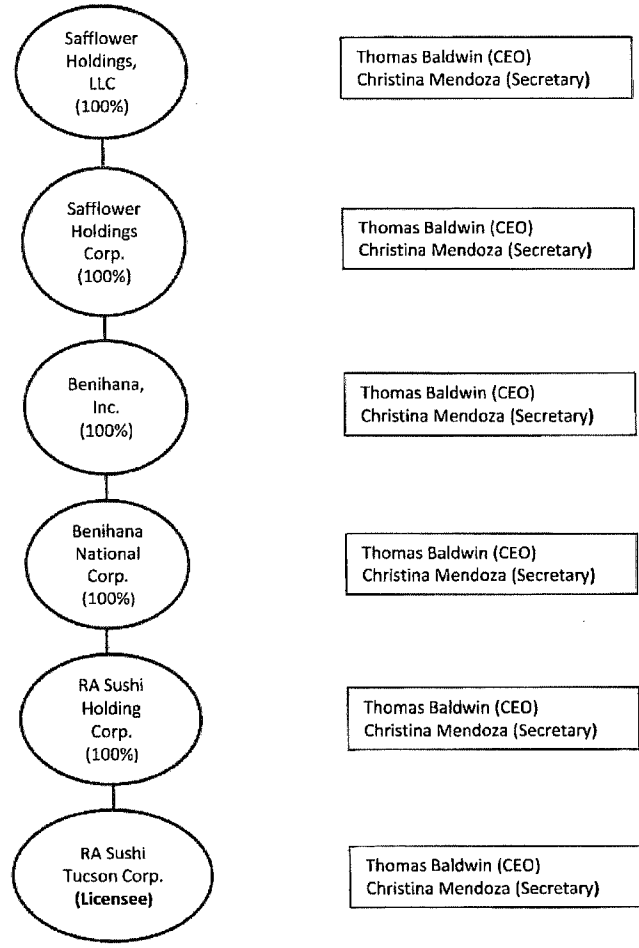

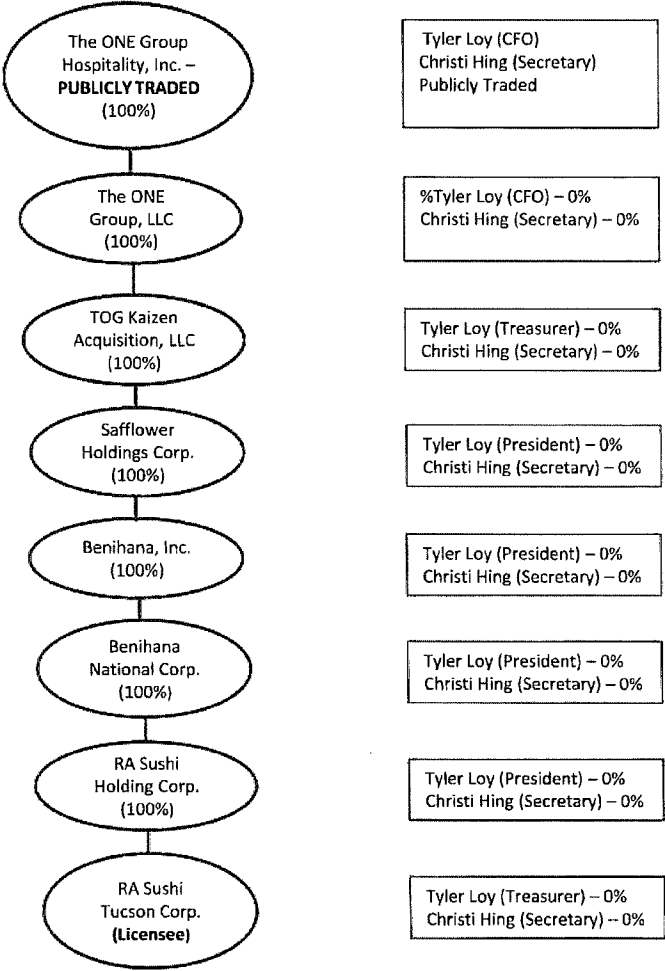


Licensing,
