Purpose:

The amendment is to extend the contract for another year and increase funding for the Senior Community Services Program (SCSEP). The SCSEP program provides a variety of job development assistance services that enable older persons and vulnerable adults to remain independent. The program provides work experience to low-income older workers so that they gain the skills that enable them to compete for jobs. Portable Practical Educational Preparation is a Subrecipient of this program.

Pima County, a body politic and corporate of the State of Arizona ("County") and Portable Practical Educational Preparation, Inc., a non-profit corporation registered to do business in the State of Arizona ("Awardee") have entered into the above-referenced contract to provide workforce development services to eligible individuals.

AMENDMENT TWO

- A. County operates a workforce development program at the Pima County ARIZONA@WORK Career Center System (an American Job Center, formerly the Pima County One Stop).
- B. County is the Subrecipient of the Senior Community Service Employment Program ("SCSEP") grant from the Arizona Department of Economic Security ("ADES").
- C. The Pima County Board of Supervisors finds that the continued provision of SCSEP workforce development services is in the best interests of the residents of Pima County
- D. County has reviewed Awardee's performance on the services finds it satisfactory.

NOW, THEREFORE, County and Awardee agree to amend the Contract as follows:

- 1. SECTION 1.0 TERMS AND EXTENIONS, paragraph 1.1 is amended as follows:
 - 1.1 The termination date is changed:

FROM: June 30, 2017

TO: June 30, 2018

1.2 The number of available renewals is changed:

FROM: four (4) additional years or any portion thereof

TO: three (3) additional years or any portion thereof

2. SECTION 3.0 – COMPENSATION AND PAYMENT, is amended as follows:

- 2.1 Paragraph 3.1 is deleted in its entirety and replaced with the following:
 - 3.1 In consideration for the services specified in Exhibit A of this Contract, County agrees to pay Awardee <u>up to \$210,772.00</u> ("the Maximum Allocated Amount").
- 2.2 **Paragraph 3.2** is deleted in its entirety and replaced with the following:
 - 3.2 Payment, up to the Maximum Allocated Amount, will be made from federal and state grants County received from various agencies (collectively the "federal awarding agency") and Pima County general funds. Funds not expended during the contract year may not be carried over for use in a subsequent contract year. Anticipated expenditures from each source are as follows, but the actual amount of grant funds utilized may vary based on the eligibility of program participants.

2.3 Paragraph 3.4.3.4 the last sentence is amended to read:

Time sheets must show the days and hours worked and must be signed by the employee and the employee's immediate supervisor with direct knowledge of the employee's efforts.

3. SECTION 33.0 - ISRAEL BOYCOTT CERTIFICATION is added as follows:

Awardee hereby certifies that it is not currently engaged in, and will not for the duration of this Agreement engage in, a boycott of Israel as defined by A.R.S. § 35-393.01. Violation of this certification by Awardee may result in action by County up to and including termination of this Agreement.

- **4. EXHIBIT A SCOPE OF WORK** is amended as follows:
- 4.1 **SECTION 3 PROGRAM ACTIVITIES GENERAL** is amended as follows:
 - 4.1.1. Paragraph 3.1.1. is deleted in its entirety and replaced with the following:
 - 3.1.1 Certify program eligibility of individuals seeking Pima County ARIZONA@WORK services.
 - 4.1.2. **Paragraphs 3.1.2.** and **3.1.3.** are deleted in their entirety and replaced with the following paragraph 3.1.2:
 - 3.1.2 Provide contact information for Pima County ARIZONA@WORK personnel with whom Awardee will interact.
 - 4.1.3. Paragraph 3.1.4. is renumbered to conform.
- 4.2 **SECTION 4 STAFF ACTIVITIES** is amended as follows:
 - 4.2.1 **Paragraph 4.1.1** is deleted in its entirety and replaced with the following:
 - 4.1.1. Notify County in advance of any Awardee's meetings or other activities which the staff providing services pursuant to this Contract must attend and which will result in an absence from Pima County ARIZONA@WORK.

- 4.2.2 **Paragraphs 4.1.3, 4.1.4 and 4.1.5** are deleted in their entirety and replaced with the following:
 - 4.1.3. Ensure staff participate in One Stop training required to successfully perform the obligations set forth in this Contract. Training is available through federal, state and local sources.
 - 4.1.4. Prior to replacing an individual providing services pursuant to this Contract, confirm continued funding availability with the Director of Community Services Employment and Training Department or his designee.
 - 4.1.5 Ensure that staff have written job descriptions consistent with Awardee's proposal for funding. Each job description must be acknowledged and signed by the individual and retained in that individual's personnel file.
- 4.2.3 **Paragraph 4.1.8** is deleted in its entirety.
- 4.2 **SECTION 8 BUDGET**, the table is deleted in its entirety and replaced with the following:

- 4.3 **SECTION 9 REPORTS** is deleted in its entirety and replaced with the following:
 - 9.1 <u>Monthly Reports</u>. No later than the fifth (5th) working day of the month for the preceding month's activities, Awardee will provide a <u>Monthly Summary Report</u> to include, at a minimum:
 - 9.1.1. Number served;
 - 9.1.2. Number placed;
 - 9.1.3. Number placed into WIB target industries;
 - 9.1.4. Number completed;
 - 9.1.5. Number exited; and
 - 9.1.6. Average wage at placement.
 - 9.2. Financial Closeout Reports. Awardee will complete and submit the following:
 - 9.2.1. <u>Preliminary Financial Closeout Report</u>, no later than July 15 of the contract year. County may require that this report be provided sooner.

- 9.2.2. <u>Final Financial Closeout Report</u>, on forms provided by County, within thirty (30) days after the end of the Extended Term. County reserves the right to require this report at a different time.
- 9.3. Awardee will provide other records and reports as requested by the Director or designee of the Community Services, Employment & Training Department.

Any other provisions of the Contract not expressly modified in this Amendment will remain in effect and be binding on the parties.
