



Good Morning,

I am a teacher here in Tucson. I work with primarily K-3 students at multiple sites. With the governors law forbidding mandating masks in schools, he has not only placed our children at high risk for the Delta variant, but immune compromised people such as myself at a higher risk.

I do not understand how a law can be past which negates the CDC, American Association of Pediatrics, a large number of medical professionals, and our own state and country health departments recommendations. By enforcing this law, young children under 12, their families, and people like myself are placed at a much higher risk. Families and people in high risk are being forced to make some very hard choices.

THE TRANSPORT OF THE STATE OF T

We know based on documentation children and the unvaccinated do get seriously ill for the Delta strain. As a result, we can see hospitals filling up with CoVID patients and "elective" surgeries being postponed.

We know the Delta strain is more contiguous (has been compared to chicken pox) and is causing a higher number of the unvaccinated to need hospital care.

We know for some vaccinated people, their immune systems may not provide protection.

We also know social distancing, improved ventilation, reducing exposure to large groups of people, and quality masking are solid means of preventing the spread of the Delta variant. It is very difficult to socially distance in classrooms with 25-30 children.

We can also see the numbers of CoVID cases rise in school districts already such as Marana and Vail.

Yet, a governor with no medical background passes a law which forbids one of the crucial pieces of advice from the CDC, masking up inside.

Please like some others, take a stand to protect our youngest community members and make masks required in schools until our children can be vaccinated.

Actually I am more than disappointed, I'm furious. You are charged with protecting the residents of Pima County. Yesterday, you failed dismally. 75% of the letters to the board supported a mask mandate. You were provided with huge amounts of evidence as to the benefits of masking in the face of a surge. Pima's community spread is now high and rising. Pediatric hospitalization is up and still rising. Our under twelves cannot be vaccinated yet -- you are quite literally feeding the school-to-hospital pipeline. Shame on you.

Well aware that you'd be flouting a blatantly unconstitutional law, you should have shown some courage.

In particular, SHAME on Rep. Christy for spreading blatant disinformation. Migrants are NOT responsible for the surge.

"Instead of trying to stop the spread of the virus, Republicans are blaming Biden for it. They claim that it is sparked by his handling of immigration on our southern border and that infected immigrants are responsible for the spike in the deadly disease.

When Biden asked Republican governors on August 3 to help or get out of the way, Florida governor Ron DeSantis responded: "Joe Biden has the nerve to tell me to get out of the way on COVID while he lets COVID-infected migrants pour over our southern border by the hundreds of thousands. No elected official is doing more to enable the transmission of COVID in America than Joe Biden with his open borders policies," and claimed: "He's imported more virus from around the world by having a wide-open southern border."

DeSantis is not an outlier. Trump has pushed this line, Fox News Channel personality Sean Hannity hammers on it, and right-wing publications from the Daily Wire to National Review to the Wall Street Journal's editorial page all insist that immigrants are to blame for the spread of the virus. Rand Paul has gone so far as to claim that

administration officials are deliberately sending infected immigrant children around the country to spread the variant. Yesterday, Trump legal adviser Jenna Ellis called for Biden's impeachment over the issue.

In fact, the administration continues to reject or expel border crossers under a public health order known as Title 42. It does permit the entry of unaccompanied minors and some vulnerable families. Migrants who cross the border are immediately required to wear masks. They are not tested at Customs and Border Patrol unless they show symptoms, but all are tested if they move into the system, and those who test positive for coronavirus are quarantined. Those slated for deportation are quarantined before they are deported. While infection rates are climbing, because of both the Delta variant and the crowding at Border Patrol, immigrants test positive at a lower rate than the rate of non-immigrants around them.

And yet, Republicans are using the deadly new coronavirus variant to stoke anti-immigrant fires.

It is cynical, it is deadly... and it takes us one more step toward authoritarianism."
