ITEM SUMMARY, JUSTIFICATION and/or SPECIAL CONSIDERATIONS:

ORDINANCE NO. 2013 - ___, An ordinance of the Pima County Board of Supervisors, regulating parking on Eunice Street in Pima County, Arizona. Staff recommends **APPROVAL**. (District 1)

The reason for this ordinance is to regulate parking on Eunice Street to provide added visibility of pedestrians and reduce congestion due to parked vehicles in the vicinity of Butterfield Elementary School.

It is recommended that both sides of Eunice Street be regulated No Stopping, Standing, or Parking from Massingale Road to Rasmussen Avenue. At the request of the Pima County Sheriff's Department and Butterfield Elementary school officials, this ordinance will extend the existing parking restrictions to reduce continued congestion due to parked vehicles. In the interest of public and school safety, additional No Stopping, Standing, or Parking signs have already been installed to supplement the existing sign installations. Approval of this ordinance will repeal Ordinance 2011-63.

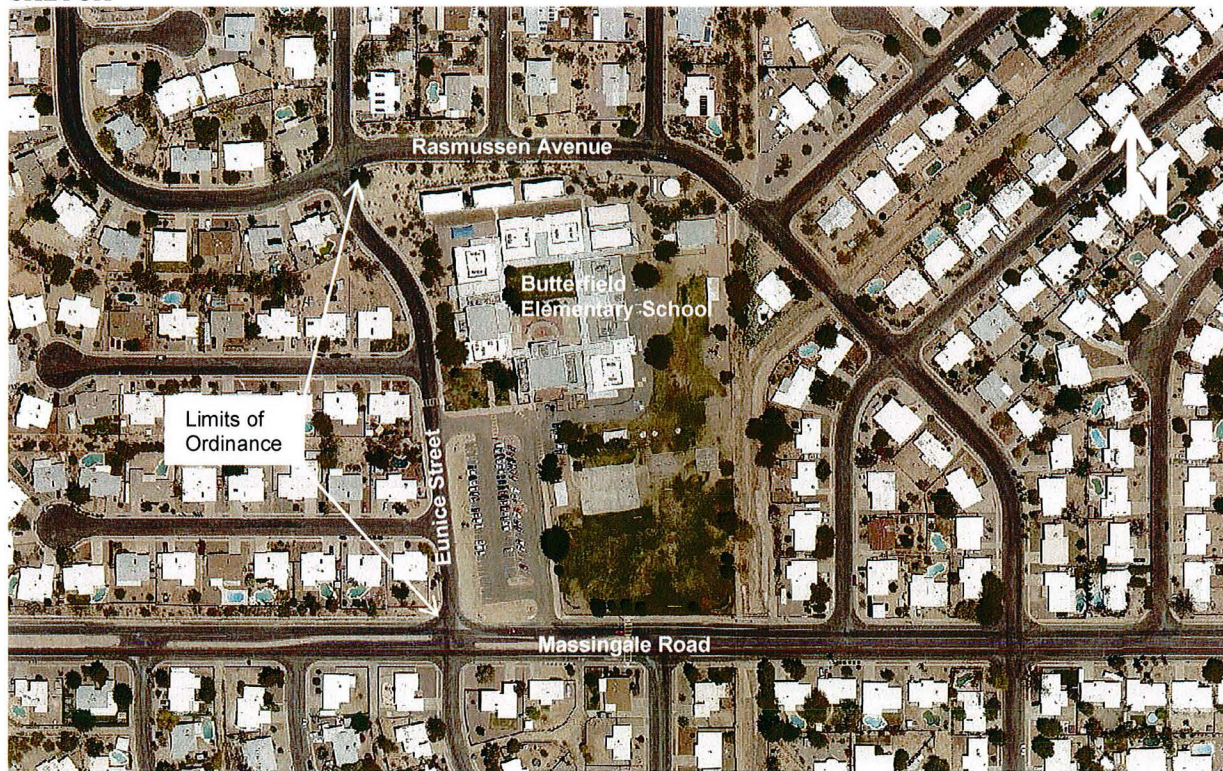

**AN ORDINANCE OF THE PIMA COUNTY BOARD OF
SUPERVISORS REGULATING PARKING ON EUNICE
STREET IN PIMA COUNTY, ARIZONA**

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-873, as amended, to regulate the stopping, standing or parking of vehicles, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined that it is in the interest of public safety that vehicles should not stop, stand or park on certain portions of Eunice Street,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. Parking on both sides of Eunice Street from Massingale Road to Rasmussen Avenue in the vicinity of Butterfield Elementary School shall be regulated No Stopping, Standing, or Parking.

SECTION 2. Ordinance 2011-63 is repealed and all other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take effect when and to the extent that signs are posted on the highway herein listed giving notice of the parking restriction.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.


